The meeting was called for the purpose of a work session on Community Center operation, and consideration of items from the May 5, 1980 regular meeting agenda.

RESOLUTION NUMBER 26-1980 - INTEREST RATE ON CONTRACTS FOR LOCAL IMPROVEMENT DISTRICTS

It was MOVED by Burgess, SECONDED by Ewald, to read Resolution Number 26-1980 (A RESOLUTION OF THE COUNCIL OF THE CITY OF MILWAUKIE ESTABLISHING A MAXIMUM INTEREST RATE FOR INSTALLMENT CONTRACTS FOR LOCAL IMPROVEMENTS) by title only. MOTION CARRIED unanimously. It was MOVED by Burgess, SECONDED by Paulson, to adopt Resolution 26-1980. MOTION CARRIED unanimously.

WORK SESSION ON COMMUNITY CENTER OPERATION

City Manager has written memo, dated May 6, 1980, with comments on proposed Operations Manual for The Milwaukie Center, developed by the Center Development Advisory Committee.

Manuel and Nickel expressed their desire to have an appointed permanent Center Advisory Committee; Ewald, Paulson and Burgess want no Committee to be appointed. All Council members expressed interest in having a revised version of the Oregon City Senior Citizens Center Building Use and Rental Policy presented for consideration.

The work session adjourned at 8:30 p.m., to go back into the continuation of the May 5 meeting.


ORDINANCE NUMBER 1460 - TOWING ABANDONED VEHICLES

It was MOVED by Ewald, SECONDED by Nickel, to read Ordinance Number 1460 (AN ORDINANCE OF THE CITY OF MILWAUKIE AMENDING ORDINANCE NUMBER 1360 BY PROVIDING FOR THE TOWING OF ABANDONED VEHICLES, REPEALING ORDINANCE NUMBER 1359, AND DECLARING AN EMERGENCY) the first time by title only. MOTION CARRIED unanimously. It was MOVED by Ewald, SECONDED by Nickel, to read the ordinance the second time by title only. MOTION CARRIED unanimously. It was MOVED by Ewald, SECONDED by Nickel, to adopt Ordinance 1460. Ordinance 1460 was put on its passage with the following roll-call vote: AYES: Paulson, Nickel, Manuel, Burgess and Ewald. NOES: None. Ordinance 1460 passed the Council and was so declared by the Mayor.


OTHER BUSINESS
