

RESOLUTION NUMBER 38-1977

A RESOLUTION REPEALING RESOLUTION NUMBER 8-1972 AND 25-1969, AMENDING RESOLUTION NUMBER 65-1968, AND ESTABLISHING MONTHLY SEWER SERVICE FEES.

BE IT RESOLVED by the Council of the City of Milwaukie, Oregon, that Resolutions Number 8-1972 and 25-1969 be repealed and Resolution Number 65-1968 be amended to indicate that monthly sewer service fees shall be as follows, commencing September 1, 1977:

1. Single family residences \$4.50
2. Apartments and multiple residences - per unit \$4.50
3. \$4.50 per unit or major fraction thereof on following:
  - Trailer Court one unit per rental space
  - High School & Junior High one unit per 10 students
  - Elementary School one unit per 17 students
  - Churches one unit per 800 cubic feet of water usage (or fraction thereof)
  - Hospital one unit per bed
  - Convalescent or Rest Home one unit per 2 beds
  - Hotel and Motel one unit per 2 rooms
  - Restaurant and Tavern one unit per 6 seating spaces (one seating space equals one chair or 24")
  - Service Station two units
  - Commercial (including all others not listed) one unit per 800 cubic feet of water usage (or fraction thereof)
  - Industrial one unit per 800 cubic feet of water usage (or fraction thereof)
4. Additional charges may be established by the City Council for excessive water contaminants.
5. Commercial and industrial accounts may deduct the actual amount of water used for air conditioning, lawn watering or put into a product if the customer installs a separate meter for such usage.


6. A reduced rate of \$2.25 for individual sewer users under Ordinance Number \_\_\_\_\_ will be applied to qualified applicants meeting the following tests:

- a) Application is made to the City Finance Department.
- b) Annual household income does not exceed \$4,000 for one person or \$6,000 for two or more.
- c) No sewer or other assessments are in arrears.
- d) The property is occupied and used by the applicant as his or her principal residence.


BE IT FURTHER RESOLVED that the monthly sewer service fees for connections outside the City limits shall be 1.5 times the charges for sewer service within the City, commencing September 1, 1977.

Be it so resolved.


