**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILWAUKIE, OREGON,  
CERTIFYING ELECTION RESULTS REGARDING ANNEXATION TO CLACKAMAS  
FIRE DISTRICT NO. 1.**

**WHEREAS**, on May 17, 2005, an election was held within the City on the question: "Shall Milwaukie annex to CFD1 for fire and emergency medical services and reduce City tax certification to prevent tax increase?" and

**WHEREAS**, that question was submitted as Measure 3-166 and was entitled "Annexation to CFD1 and Reduction of Tax Certification"; and

**WHEREAS**, Section 13 of the Charter requires the certified election results be made a part of the record of proceedings of the City Council, and

**WHEREAS**, the City has received certified results of the May 17, 2005, election from the Clackamas County Clerk, a copy of which is attached as Exhibit A;


Now, therefore, the City Council of the City of Milwaukie resolves as follows:

SECTION 1: The City Council certifies that Measure 3-166, Annexation to CRD1 and Reduction of Tax Certification was approved by the electors of the City of Milwaukie, with 2,338 votes in favor and 392 against the measure, of 2,842 total votes cast. The City Council certifies that the complete results of the election on Measure 3-166 are as stated in Exhibit A.




SECTION 3: This resolution takes effect immediately upon passage.
