



## School District accepts Waldorf's bid over City's

On August 16 the North Clackamas School Board accepted the Waldorf School's bid of \$3.65 million to purchase the Milwaukie Jr. High and surrounding grounds.

The City of Milwaukie entered a bid of \$3.2 million, and was the only other entity to submit a proposal. The City upped it's bid in the last week leading up to the August 16 School Board meeting from the initial bid of \$2 million after obtaining additional funding from Tri-Met and approving a loan from the City's Water Reserve Fund.

The City had hopes of purchasing the site and converting the buildings into a community center and transportation station while preserving the athletic fields and pool for community use. The City and School District had been negotiat-

ing the purchase of the site for the past three years, with offers ranging from \$2.8 to \$3.2 million.

As stated on it's website at <http://www.awsna.org>, the Waldorf Education places heavy emphasis on arts and music and learning through imagination and imitation. There are more than 800 Waldorf schools in over 40 countries; more than 150 in North America.

Leaders of the Portland Waldorf School have vocalized a commitment to share the school building, playing fields and swimming pool with the community as long as such an arrangement did not interfere with daily classes.

The Waldorf School is planning to occupy the Milwaukie site in September of 2002. ■

## Grant for North Industrial study

In early August the Oregon Transportation & Growth Management program awarded the City of Milwaukie a grant of \$100,000 to fund a land use and transportation study of the City's North Industrial area.

This study will be instrumental in developing a plan to attract tenants, and the jobs these tenants will bring, to this currently under utilized district of Milwaukie.

The proposed project is intended to:

- Protect the City's job-generating land base, while allowing the area to evolve and remain responsive to

## ODS builds model partnership

Not long after ODS Health Plans purchased the old Pendleton Woolen Mills building Andrew Franklin, the corporation's Vice President of Operations, met with Historic Milwaukie Neighborhood Chair, Ed Zumwalt, at a local diner.

Over a cup of coffee Andrew unrolled the renovation plans for Ed's review, and at the next Neighborhood Association meeting, a half dozen ODS representatives addressed the Historic Milwaukie residents and fielded questions concerning issues such as traffic and the environmental impacts of Johnson Creek.

"You could tell (the ODS representatives) wanted to know our concerns, and you could tell they were really listening," Ed said.

Andrew says forging genuine partnerships with the local community is a part of the ODS culture.

"We wanted to build a good relationship with the Neighborhood Association because if we didn't do it right, we could run into some Neighbor problems," Andrew explained. "So we wanted to do it right not only for

the sake of doing it right but because it was a sound business decision as well."

ODS provides insurance to over 600,000 Oregonians and their dependents through group and individual medical and dental plans.

The facility that resulted from the public's input and the work of the architects and designers is a beautiful facility. Maintaining the feel of the old industrial mill, the ODS facility stands as one of the City's most modern and architecturally interesting buildings. ■



# Council advances transit recommendations

At their August 20<sup>th</sup> Work Session the Council reviewed comments from the community that were shared during the July 26<sup>th</sup> Town Hall and the August 13<sup>th</sup> Open House.

After reviewing the information they discussed the options and made recommendations for what should be studied in the Environmental Impact Phase of the project.

The Planning Commission was scheduled to review the recommendations at their August 28<sup>th</sup> meeting. Their findings were not known at press time.

The community comments showed a clear preference for light rail over busway. The comments also showed that people preferred Bus Rapid Transit along Highway 224 as a means of extending transit service from the Harrison/224 area out to the Clackamas Town Center. The Council's recommendations were consistent with the preferences expressed by the Milwaukie Neighborhoods through their 14 Points.

In terms of next steps, the South Corridor Policy Group will meet on September 17<sup>th</sup> to give formal direction to the project staff, as to what will go forward for further study. It is expected that they will endorse the Milwaukie recommendations. The study will probably take 12

to 14 months to complete. As preliminary results of the environmental impact study become available throughout the process, there will be periodic community updates provided at your local Neighborhood meetings.

## Light Rail Recommendation

The recommended alignment calls for a Tacoma St. station and Park & Ride, a Southgate station and regional transfer facility, a smaller station at the Junior High with reduced bus service, and a Lake Road & 21<sup>st</sup> terminus and Park & Ride. The Council felt that this alignment did the best job of serving the resident commuters while preserving neighborhood livability, serving the downtown businesses and customers, preserving access to the riverfront, encouraging redevelopment of the northern industrial area, and providing additional, evenly distributed parking at various points along the line. They also felt that this option showed the greatest promise in terms of future extensions to the east, west and south while creating the least impact to Milwaukie's natural and developed environment.

## Busway

No preferred alignments: Community comments showed that people were concerned that busway, either above,

at, or below grade, would be detrimental to Milwaukie's natural and built environment because of its impacts on area wetlands and several local businesses that would be displaced. The Council chose not to recommend any busway alignments.

## Bus Rapid Transit

Community response indicated people preferred extensions to the east if a bus rapid transit system were implemented. The Council chose to recommend Bus Rapid Transit along Highway 224 through Milwaukie and beyond its borders from the Linwood/ Harmony area to the Clackamas Town Center via Harmony or 224, with no park & ride in the Linwood/Harmony area.

Milwaukie Neighborhood officers are serving as the local citizen advisory committee to the South Corridor Project. - changing market conditions.
- Establish clear, modern land use and development regulations responsive to the emerging market for industrial development.
- Identify if existing transportation infrastructure can accommodate the redevelopment scenarios, and if not,

- develop a plan to accommodate any infrastructure needed to provide the level of access necessary to attract investment in industria redevelopment.
- Seek input and participation from area property owners and adjacent Neighborhood leaders.

In the upcoming months City Staff will work with the Oregon Department of Transportation in developing a full scope of work for the project and a Request for Proposals to recruit a project consultant.

The project is expected to begin in early 2002. ☒

On Thursday, August 16, 2001, the North Clackamas School District voted to accept the bid of the Portland Waldorf School to buy Milwaukie Jr. High for \$3.65 million, one of the most destructive moves that could befall our City.

This beautiful school, deeply rooted in the hearts and history of our City, was ceded to the District by Milwaukie in 1971 as part of a consolidation, and in the thirty years since has been supported by our tax dollars.

This move by the District, although it may be legal, is at least immoral, unethical, unconscionable and a terrible blow to our community – another large governmental entity treating us with impunity and destroying many of our plans, hopes and dreams.

The District again proved that their

allegiance is to the bottom line only – the almighty dollar. These supposed guardians of our youth are completely ignoring our desperate need in Milwaukie for a place for some of our less fortunate students to go after school – an oasis for them, an alternative to the streets.

One Board Member had the arrogance to say that accepting the bid was the best thing to do for all of the students of the district. I believe this means they are going to funnel the proceeds out of Milwaukie and into other areas, areas that already have community centers paid for by our tax dollars.

The school will now be used exclusively by children from out of the area – and whose parents have paid no tax money towards its maintenance.

The Waldorf people have no ties or allegiance to our community, and although they have made many grandiose promises,

do not be surprised if in a few years we are scrambling for dollars to save the property from developers. After all, Waldorf is a private entity and can sell the property at any time.

To ensure peace in the community, Waldorf must withdraw its offer, the District must cancel the agreement with them, and the school must be offered to Milwaukie with negotiations to ensue.


