## County sues City - rate still undetermined

On Oct. 6<sup>th</sup> a judge will rule whether or not the City has to issue building permits to Clackamas County Service District #1 to allow work on the Kellogg sewer plant. The district filed a lawsuit against the City on Sept. 2<sup>nd</sup>.

The City contends the building permits need to go through the City's standard land use process as the plant is located in a Water Quality Resource Area, is in the Willamette Greenway and a determination has to be made if the proposed work is an intensification of the site's use.

"The County is trying to establish a precedent by which it can modernize the plant without any City oversight," says Kenny Asher, Milwaukie's Community Development and Public Works Director.

The County contends the work is simple maintenance, not modernization, and the work being proposed is to repair existing equipment and therefore does not require a land use review.

In a separate issue, the City and the service district are still at odds over the new sewer rate the district has imposed on the City and its customers. Beginning in August, the district began billing Milwaukie residents \$25.31 per household, up from \$11. City Council has rejected that rate, refusing to pay its bill to the district and, in turn, refusing to pass that new rate on to its customers.

The rate increase finances the expansion of the district's wastewater system needed to accommodate the growth that's occurred

## Light Rail meetings to focus on City & Tacoma stations

Milwaukie's single light rail station to be located near the intersection of 21<sup>st</sup> Avenue and Lake Road in our Downtown will be the focus of a Workshop held Oct. 5<sup>th</sup>, from 6:30 to 8:30 p.m. at Bridge City Community Church, located at 2816 SE Harrison St.

Community members will be asked to provide input on a number of issues concerning the station's design, including safety and security, pedestrian access, bike access, bus connections and public art.

Discussion will also center on how the station will connect with Main Street activities and the still developing South Downtown Plan, of which the station represents a significant element.

## Connecting Milwaukie

As we watch summer's fading glow transition into fall's brilliant colors, I am filled with gratitude for our beautiful state we are most fortunate to live.

To live in a metropolitan region and be able to take a daytime drive to experience the ocean, mountains, desert, or gorge is amazing. Wouldn't it be even more spectacular to view Oregon's landscape by train travel to all these destinations????

America's investment in high speed passenger rail is albeit decades delayed but nonetheless necessary to position our country as a whole to be part of a sustainable solution to deflect our dependence on foreign oil. On a world scale, our nation is behind the curve of progress where rail travel is concerned. But investment comes at a price both in dollars and in design. Planning rail infrastructure should take into account multiple elements, including preserving both livability and the environment. Route and design details are of utmost significance as Milwaukie citizens are discovering as engineering plans for light rail are revealed. Proposed plans to run high-speed passenger rail through downtown Milwaukie would seem contrary to what our community values and needs.

Keeping costs down is always a concern in any project. However, the time, effort, and dollars invested in large scale public projects in general and rail projects in particular would have me doubting the feasibility of any project if it isn't built right the first time. There will be no second chances to get it right. We must get it right on rail, both light and high speed. Alignments and design for rail project plans should be thoughtfully executed with livability and environmental habitat remaining unharmed.

The construction costs may be high but the consequences of living forever with infrastructure that continuously impacts the environment and people's livability is even higher.

Make your voice heard at upcoming public meetings. It's your state, it's your town, it's your money and it should be your decision and input that guides project planning and design. Projects and impacts are forever.

## Downtown plan advances

CES, the City's consultant that's developing a plan for Milwaukie's South Downtown will present its latest work to City Council at its Oct. 20<sup>th</sup> meeting. Council meetings begin at 7 p.m. and are held in City Hall, 10722 SE Main St.

The CES approach hinges on developing a "pattern language" that when implemented over time, will create a downtown neighborhood that puts human needs and activities ahead of developer profits and architectural style. The document describes a place where people will want to make homes, establish businesses, and spend time.

"The pattern language helps to ensure that future development in the South Downtown does not lose touch with what the people of Milwaukie actually want to see down there," says Kenny Asher, the City's Community Development Director. "It's the first pattern language ever created for a City, and it represents an amazing consensus about what that little area can become."
