On Motion by Mullan, seconded by Kelso "carried" Street lights were ordered at the following places Monroe St.near the residence of M Bonfigt, on Main St and Harrison, and the arc light at the City Hall was ordered moved to the next pole towards the carding mill and the Recorder was instructed to notify the Lighting Company.

On Motion by Kelso seconded by Lehman "carried" a levy of Three (3) Mills for general purposes was ordered and the Recorder was instructed to so notify the County Clerk .
