On motion the City Marshal was instructed to enforce the Dog Ordinance at once, and take up all dogs found running at large without a license, *and if this order was not complied with by, said Marshal the Council would declare his office vacant.*

Mr. O. Wissinger was requested to purchase a new rope for the Town Flag and present the bill to the town for payment.

Mr. J. A. Zimmarman addressed the Council and asked to have the liquor license of the Milwaukie Country Club transferred to the Milwaukie Tavern. He was instructed by the Mayor to present his request in writing at the next meeting of the Council.
