ORDINANCE NO. 624

AN ORDINANCE AMENDING ORDINANCES NO. 481 AND NO. 559, AND PROVIDING FOR THE REZONING OF CERTAIN REAL PROPERTY LOCATED WITHIN THE BOUNDARIES OF THE CITY OF MILWAUKIE, OREGON.

THE CITY OF MILWAUKIE DOES ORDAIN AS FOLLOWS:

Section 1. That Ordinance No. 559 of the City of Milwaukie, Clackamas County, Oregon be and it is hereby amended so as to remove from the area of said city therein described and zoned 3R-2 Special the following described property, to-wit:

The easterly five feet of Lot 2, Block 1; all of Lot 22, Block 1 and the Westerly portion of Lot 21, Block 1, described as follows:

Beginning at the southwest corner of Lot 21, Block 1, Leo's First Addition, running thence northerly 200 feet along the westerly line of said Lot 21 to the northwest corner thereof, thence N.89° 05' east along the northerly line of said Lot 21 a distance of 6.39 feet to a point, thence south 200 feet to a point, thence S. 89° 05' west along the south line of said Lot 21, a distance of 4.7 feet to the point of beginning, all in Leo's First Addition, Clackamas County, Oregon.

Section 2. That Ordinance No. 481 be and it hereby is amended, together with so much of the zoning map of the City of Milwaukie, Oregon, as relates thereto, so as to include within the Commercial Zone established by said Ordinance and map the property set forth and described in Section 1. of this Ordinance.

That Ordinance Number 481 be and it hereby is amended, together with so much of the zoning map of the City of Milwaukie, Oregon, as relates thereto, so as to include within the Commercial Zone established by said Ordinance and map the property set forth and described in Section 1, of this Ordinance.
