

ASSISTED ANNEXATION APPLICATION INSTRUCTIONS

STEP 1: ELIGIBILITY

Property owners who meet the following three criteria are eligible for annexation assistance through the City of Milwaukie's Annexation Assistance Program.

- The property will retain the same or equivalent zoning designation upon annexation.
- The use(s) on the property will conform to the City's zoning code upon annexation.
- All property owners, and at least one-half of all registered voters living at the property, agree to annex by signing the annexation petition.

STEP 2: ANNEXATION APPLICATION

There is no fee to annex to the City through the City's Annexation Assistance Program. Eligible property owners apply for annexation by completing and signing the following three forms (attached).

- Assisted Annexation Application
- Annexation Petition
- Population Research Center Census Form (one for each housing unit)

The Population Research Center is responsible for reporting population changes to the State of Oregon. As a result, a census form must be completed for each housing unit (e.g. apartment, condominium, single-family house) that is annexed to the City of Milwaukie. Please make and complete additional copies of this form as necessary. If the property to be annexed contains no housing units, write "NONE" next to HOUSING TYPE on the form.

Completed forms <u>must</u> be delivered in person by the property owner to the City's Planning Department at 6101 SE Johnson Creek Blvd during regular business hours. To schedule an intake appointment outside of regular business hours, contact the Planning Department.

STEP 3: APPROVAL

The Annexation Assistance Program provides for annexation of multiple properties together at one time at least once each year. Check with Planning Department staff for the date of the next City Council meeting when assisted annexations will be considered.

Annexations to the City require approval by City Council, processing by Metro, and then filing by the Secretary of State. Annexations become effective the date they are filed by the Secretary of State. This process can take up to 8 weeks after City Council approval.

Building permits, including applications for sewer connection, may be submitted to the City for review after City Council has approved the annexation. However, building permits cannot be issued by the City until the annexation has been filed by the Secretary of State.
