



Council sets bond measure for May 2014

City Council directed staff at its July 16th Work Session meeting to place a bond measure on the May 2014 ballot that, if passed, would collect revenue to preserve the City's core services and save tax dollars over the long-term by paying off the City's obligation to TriMet for capital improvements associated with the Portland - Milwaukie Light Rail Project.

Council is also considering adding other community service initiatives to the bond measure, including a Ledding Library expansion, construction of four Neighborhood Parks, and the completion of Milwaukie Riverfront Park.

Bonding the project would allow the City to borrow money at today's low interest rates. A bond covering the light rail obligation would cost the owner of a \$200,000 home about \$38 a year.

Council will conduct more research and outreach to determine what the composition of the bond will be, and staff will make regular reports on the effort at City Council meetings leading up to the election.

Seeing it through

They say time is relative. For Lindsey Gotter, who's 10 years old, a "full school-days-worth" of time is a lot. That's the amount of time she and the six other girls of Girl Scout Troop 42610 spent going door-to-door to collect some 2,000 cans and bottles and then sorting and putting them into machines to raise more than \$100 for Milwaukie's K-9 unit.



Lindsey's Mom, Kim, is the Troop Leader, and she remembered reading the story of Milwaukie's K-9, Jag, passing away from cancer, and the subsequent fund-raising efforts to support the K-9 program from a note sent

out by Sue Richardson, a member of Milwaukie's Public Safety Advisory Committee. Kim says the scouts of Troop 42610 rallied behind the cause.

"When they heard the dog had passed away, that really meant a lot to the kids," Kim said. "They really wanted to do something and make a difference."

Kim said having the girls identify a cause, develop a plan to support it, carry it out, and then hand a check over to Milwaukie's K-9 officer Les Hall (above), will serve as life lessons for the scouts.

"That was a key motivating factor - to see it all the way through, which is hard for kids today," Kim said.

Light Rail work calls for two more closures

The portion of **Monroe between 21st and 25th Avenues** will be closed **Mon., Aug. 5th through Sun., Aug. 25th** so construction crews can install a new stormwater line, light rail tracks and heavy rail tracks at the Monroe Street rail crossing in Downtown Milwaukie.

Safety improvements made at this crossing and other Downtown rail crossings as part of the Portland - Milwaukie Light Rail Project will enable the

Realizing Riverfront Park

Back in 1998 the City identified the riverfront park as a priority project. In the last couple years Council has rated the park as a top priority and we are starting to see things take shape.

At the end of the year in 2012, we saw the opening of Klein Point on the north end of the park through the help of funds received by Metro and a generous land donation by the Klein family.

This year we applied for two grants and asked for matching funds from the Kellogg Good Neighbor fund to build a trail, boat ramp, restrooms, parking and to relocate power poles. We were successful and will receive funds from the Oregon Marine Board and Oregon Parks and Recreation. We now have approximately \$2.5 million to get Milwaukie Riverfront Park underway.

By the end of next year we will have a re-contoured park, pathway by the river, a new boat launch, two parking areas and other amenities.

We still have a ways to go to finish the park, but we are getting there. So far the park is really turning into a regional partnership and I'm sure folks from all over will see this as an attraction and come visit our City.

We still have a ways to go. There's a capital campaign to help raise the money needed to complete the middle section of the park. Know a business that wants to sponsor a community space or a person that would like to see a playground at the river? Let us know, we want to make this YOUR park.

City to enact its Quiet Zone, which will silence light rail and freight train horns as they pass through town, except in cases of emergency.

Local access to businesses and residences within the closure area will be maintained at all times. Construction

work hours are 7 a.m. to 7 p.m., Mon. through Fri., 8 a.m. to 5 p.m., Sat. and Sun. The closure will be in effect at all hours.

McLoughlin Boulevard will be closed between SE Washington Street and SE River Road from 10 p.m., Fri., Aug.

16th to 5 a.m., Mon., Aug. 19th, so crews can place the large steel girders for the light bridge that will span 99E.

Updates on projects from the Community Development Department

Good News about Grants for Riverfront Park

The Oregon Marine Board has awarded the City a grant of \$1.2 million (with a local matching contribution of \$1 million from the Kellogg Good Neighbor Fund) to build a new boat ramp, parking for trailers and cars and a restroom in Milwaukie Riverfront Park.

The City received a second grant from the Oregon Parks and Recreation Department for Milwaukie Riverfront Park construction. This grant, for \$220,000, will help construct a pathway, install plantings along the river bank, and re-grade the northern portion of the park property. Construction will begin in June 2014.

Transportation System Plan (TSP) Update

Work is proceeding on the update to the City's Transportation System Plan. A report summarizing the results of a public meeting held on June 3rd is now available for review on the City's website. A big thank you is due to everyone who attended this meeting and contributed their ideas. Staff is preparing a draft of the updated TSP for public review, which will be available in early to mid-August. Two public Open Houses are being planned, one in late August and the second in early September. After those meetings, the adoption process is expected to start, with Planning Commission formal review in September and City Council consideration in October or early November.


Tacoma Station Area Plan Adopted

The City Council adopted the Tacoma Station Area Plan (TSAP) in early July. The plan covers the area near the future Tacoma Street Light Rail Station, scheduled to open in 2015. The plan allows new land uses in this manufacturing area, focusing on office and commercial uses to increase the number of jobs that are accessible from light rail. It also identified transportation projects that can increase pedestrian and bicycle access to and from the station.

Our first public water well, piping, and City Water Works was funded by the WPA, along with street improvements better connecting us to Superhighway 99. We have two institutional buildings. City Hall (the last WPA project to be administered), and Milwaukie Junior High School, currently the Waldorf School, (the first Junior High was removed to build City Hall). Both of these buildings are registered Milwaukie Significant Historical Properties and are cornerstones of our City's growth, education, and involvement. President Roosevelt would be proud to see each building, still to this day, as monuments for his expectations.

August is the time when we see a lot of garage sales and recreational vehicles around town.

You should be aware that our code prohibits the parking of motorhomes, travel trailers, and boats in the right-of-way, which includes the street and the gravel shoulder of our streets. Please park these vehicles in your driveway, even if you are just loading it up with supplies before you head out of town.

Garage sales are okay in the City as long as they do not exceed 72 hours and aren't held more than twice in a calendar year. Also, please do not put signs for the sale in the right-of-way or on utility poles - that's a violation of our Sign Code. If you have questions, please call me at 503-786-7409. The Chief's Corner

The month of August is a great time to take a vacation and many of our residents do exactly that.

Unfortunately, it is also a time that the Police Department traditionally sees an uptick in the number of residential burglaries. In addition, the City has a number of residential properties that are vacant pending a foreclosure or traditional sale. No one knows your Neighborhood better than our own residents. So if you see unusual activity around a vacant home or someone suspicious in your Neighborhood, do not confront them yourself, rather, contact the Police Department at 503-786-7500. We will be happy to check out the situation for you. This will help us keep our Neighborhoods and our residents safe. Thanks.

Road projects tie-in years of infrastructure work

This year the Street Surface Improvement Program (SSMP) will target two major Downtown streets that, once completed, will tie together a series of street, storm, water and wastewater infrastructure projects that have been constructed over the past six years. The SSMP was created by Council in 2006 to provide funding for local road projects.

- Main Street Repaving Project :** Late August through mid-September
Project Details: 12 sidewalk ramps reconstructed - 2.5 inches of existing roadway will be ground away and replaced with 2.5 inches of asphalt - New pavement markings: center line, crosswalks, and parking spaces. Night work is targeted to begin the week of Sept. 8th.
Traffic Impacts: Main Street will be closed between 7 p.m. and 7 a.m. during the project and detours will be in place. Main Street will be open for vehicular access during non-working hours.
- Harrison Street Reconstruction Project:** Mid-September through October
Project Details: Existing asphalt will be milled away, the base will be treated with cement and a fresh 6 inches of new asphalt will be laid on top. New pavement markings – center line and parking spaces.
Traffic Impacts: Harrison Street will be closed during construction hours and detours will be in place.

City to slurry-seal streets

In July the City's Streets Department crack-sealed streets in the Linwood and Lewelling Neighborhoods so that in August they could be slurry-sealed, a process that will leave seven miles of roadway looking brand-new.

This type of treatment will prolong the roadways' lives at a cost significantly lower than a replacement project later down the road. Residents and businesses in the work areas will be alerted before the work begins, as access will be limited during the work. Sidewalk ramps repaired

A \$132,000 grant from Clackamas County will allow the City to reconstruct about 50 sidewalk ramps throughout the City so that they are in compliance with the Americans with Disabilities Act.

Ramps near City facilities and on Main Street will be targeted in this first phase. The effort is part of a long-range plan to bring all of the City's sidewalk ramps into compliance.

City close to quieting train horns through town

In August, City Council is expected to award the contract for construction of the safety improvements at the 37th Avenue and Oak Street rail crossing that will allow the City to enact its Quiet Zone designation to quiet train horns on the Union Pacific (UP) Railroad.

Work at these crossings includes adding traffic islands and raised curbs that create barriers in order to prevent vehicles from crossing over the center lane to avoid the railroad crossing arms. Construction will take place in September and October. Traffic impacts will include single-lane closures with the use of flaggers.

The Quiet Zone is hoped to be in place by the end of 2013, and then trains on the UP line would only sound their horns in cases of emergency. The City has constructed the required improvements at two other UP crossings in town to allow the Quiet Zone to be enacted.

The Portland - Milwaukie Light Rail project is building Quiet Zone-ready crossings on the Tillamook Branch so that all trains will not be required to sound their horns when traveling through Milwaukie.

Each Neighborhood Association has a Land Use Chair monitoring applications the City receives. To help track the process, these are upcoming Land Use/Development Review hearings, and Planning

Commission (PC) Agenda items. Dates are subject to change. Check the City's website for details.

Flaggers, trucks, noise, steel plates, missing embankments, mountains of dirt and rock, missing trees, new street lights, water pipes, loaders, repaired sewer pipes, new sidewalks, street surfaces, and then ... light rail and hopefully, an end to the loud, moaning freight train horns as they lumber through our Neighborhood.

The post office will lose its front-door parking; trucks from the lumber yard will struggle to get around new concrete road dividers required to make a rail 'Quiet Zone' possible. Our NDA opposes tall, high density development in the south downtown as being out of scale and over what is projected to be needed in the region's 2035 plan.

The City is updating its Transportation System Plan - and they listened to the NDA's and residents who expressed their opinions. AND residents convinced TriMet not to close the north Main Street Park & Ride lot. Yeah team!


