

TOWN HALL MILWAUKIE, OREGON, JANUARY 12ND. 1917.

The one hundred seventy-eighth (178) regular meeting of the Town Council was held on the above named date. Meeting duly called to order. Present, Mayor Snyder, councilmen, Grasley, Shindler, Miller, Bates and Seavey, Recorder Mathews, Marshal Riley and Treasurer Streib. The minutes of the meetings of the Council held on the 5th, 11th and 21st days of December, 1916, were read and approved as read. Mayor Snyder appointed the following Committees for the year 1917; Finance Committee, J. J. Miller, W. H. Grasley and Wm. Shindler; Street and Water Committee, Wm. Shindler, J. W. Bates and G. A. Seavey; Light Committee, J. J. Miller, W. H. Grasley J. W. Bates; License Committee, W. H. Grasley, Wm. Shindler and G. A. Seavey; Fire Committee, J. W. Bates and W. H. Grasley.

Upon the request of Mayor Snyder the following resolution was read and upon motion duly made and carried, the resolution was adopted by the Council as read:

Resolution No. 1-1917

RESOLVED. FIRST- That the Marshal's salary be Ten Dollars, (\$10.00) per month for the performance of the duties of the office as set forth in the Town Charter:

SECOND- That the Street and Water be confined under one head and one Committee:

THIRD- That the Marshal elect shall be given first opportunity to do the work on the Streets and Water System under the supervision of the Street and Water Committee at a salary of Sixty-five Dollars (\$65.00) per month. The Marshal refused to accept the offer. The matter of selecting some one to do the work on the streets and Water System was referred to the Street and Water Committee to report at the next meeting of the Council. The Treasurer's report was read and ordered placed on file. Upon motion duly made and carried, the Recorder was instructed to notify Mr. Carver to meet with the Council at the next regular meeting and show cause why his franchise should not be revoked. The following bills were read and allowed by the Finance Committee, and upon motion duly made and carried, the Recorder was instructed to draw warrants in payment of the same:

An adjourned meeting of the one hundred seventy-eight (178) regular meeting of the Council was held on the above named date. Meeting called to order by Mayor Snyder. Present, Mayor Snyder, councilmen, Grasley, Miller, Shindler, Bates and Seavey, Recorder Mathews, Treasurer Streib and Marshal Riley.

Councilman Shindler of the Street and Water Committee reported that the Committee had received an application from Charles Mullan in which he agreed to do the work of Water Supt. and Street Commissioner for the sum of \$75.00 per month. An application from Harry M. Chitwood to do the work of Water Supt. and Street Commissioner for the sum of \$60.00 per month was read. The Street and Water Committee recommended that Mr. Mullan be employed to do the work of Water Supt. and Street Commissioner at a salary of \$75.00 per month. Upon motion duly made and carried, the recommendation of the Street and Water Committee was adopted.

CITY TOWN HALL, MILWAUKIE, OREGON, FEB. 6TH. 1917.

The one hundred seventy-ninth (179) regular meeting of the Town Council was held on the above named date, Meeting called to order by Mayor Snyder. Present, Mayor Snyder, councilmen, Grasle, Rates, Shindler and Seavey, Recorder Mathews, Treasurer Streib, and Marshal Riley. The minutes of the one hundred seventy-eight regular meeting of the council held on the 2nd. day of January, 1917, and the minutes of the adjourned meeting of the one hundred seventy regular meeting held on the 10th day of January, 1917, were read and approved as read. The report of the Finance Committee on the books of the Treasurer and Recorder was read and ordered placed on file.

A communication from Mark Levy and others in regard to repairing road in front of their property was read and referred to Street Committee. A communication from ex-mayor G. C. Pelton in regard to hall rent was read and ~~#####~~ ordered placed on file. Petitions requesting the Council to install arc lights at the following places: 21st & Adams Streets; At N. R. Harvey's place and at I. V. Hams place were read, ~~#####~~ and upon motion duly made and carried, the petitions were allowed, and the Light Committee was instructed to determine the proper place for installing the same.

A petition signed by the people living along the Carver car line requesting the Council to ~~compell~~ Mr. Carver to stop running steam locomotives in and through Milwaukie and to revoke his franchise if he failed to comply with the request, was read and ordered placed on file. Upon motion duly made and carried, Ordinance No. 135 was taken up for the third and final reading. The ordinance being read the roll call showed the following result: Ayes, Grasle, Shindler, Rates and Seavey. Nays, none. Absent, Miller. Ordinance No. 135 passed. Mayor Snyder appointed the Finance Committee to meet with a Committee from the Commercial Club to discuss the matter of accepting funds from the Carnegie Library fund for a Library for Milwaukie. Upon motion duly made and carried, the recorder was instructed to notify Mr. Carver that his franchise had been revoked, and that he had forfeited all his ~~to~~ the use of the Streets in the Town of Milwaukie. Upon motion duly made and carried, Mr. Roberts was granted permission to remove some dirt from the street in front of his property upon the condition that he leave no holes in the street. The following bills were allowed by the Finance Committee, and upon motion duly made and carried, the Recorder was instructed to draw warrants in payment of the same:
