The two hundred twenty-sixth regular meeting of the Council of the Town of Milwaukie was held on the 4th day of January, 1921. Meeting called to order by Mayor Snyder. Present, Mayor Snyder, councilmen, Miller, Albee, Shindler, Hart and Counsell, Treasurer Streib and Marshal Reed.

Upon motion duly made and carried, the Finance Committee was instructed to examine the Treasurer's accounts and ascertain how much cash the Town would be able to pay the County for paving and pay the same to the County, and to cause warrants to be drawn in favor the County in payment of the balance. The Mayor instructed the Finance Committee to examine the Recorder's and Treasurer's books for 1920 and make a report at the next regular meeting the Council held in February. Upon motion duly made and carried, the Council adjourned subject to the call of the Mayor.

An adjourned meeting of the two hundred twenty-sixth regular meeting of the Council was held on the above named date. Meeting called to order by Mayor Snyder. Nays, none. Ordinance No. 172 passed the first reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 172 was taken up for the second reading and read by title only. Upon motion duly made and carried, the rules were suspended and ordinance No. 172 was taken for the third and final reading and read by title only. The roll-called showed the following result: Ayes, Miller, Shindler and Counsell; Nays, none. Ordinance No. 172 passed.

A communication from James Callahan requesting the Council to allow him keep his pool room open on Sundays and reduce the license fee was read and, also a petition requesting the ~~requesting~~ Council to reduce the pool room license fees and allow pool rooms to run on Sundays was read. Upon motion duly made and carried, the matter was referred to the License Committee to make a report on at the next regular meeting of the Council. The resignation of Mr. Shindler as a member of the Boxing Commission was read, and upon motion duly made and carried, his resignation was accepted. Mayor Snyder appointed A. Thomas a member of the Boxing Commission to succeed Mr. Shindler. Upon motion duly made and carried, the appointment of A. Thomas as a member of the Boxing Commission was confirmed.
