

The treasurer's monthly report was read and ordered filed.

The fire chief's monthly report was read and ordered filed.

A communication from the L.D. McFarland Co. requesting a reduction of water rates was read. Water Superintendent Bevington stated that the L.D. McFarland Co. was already receiving the rates requested.

The application of the Safeway Stores, Inc. for a package beer license was read. It was moved by Burdick and seconded by Wills that consideration of the application be postponed until the applicant had paid arrearages in license fees. Motion carried and so ordered.

The application of Vera Milian for a wine dispensing license recommendation was read. It was moved by Burdick and seconded by Shrock that the recommendation be granted. Motion carried and so ordered.

The Recorder stated that it was cost eighty-four cents per man to insure the members of the volunteer fire department under the Workmen's compensation law. It was moved by Burdick and seconded by Walsh that insurance under the Workmen's Compensation Law be secured for twenty-four members of the Fire Department. Motion carried and so ordered.

Robert Paulson requested that repairs to the street at 31st and Sellwood streets be made. The matter was referred to the Street Committee for investigation and report.

Councilman Shrock brought up the question of establishing a parking strip in front of the postoffice and of establishing a parking period of one hour on Monroe Street between Front and Main Streets during the day. It was moved by Shrock and seconded by Wills that the Recorder prepare and post an ordinance establishing a one hour parking limit on Monroe Street between Front and Main Street between 8 A.M. and 6 P.M. and also establishing a loading zone in front of the postoffice. Motion carried and so ordered.

Councilman Wills brought up the question of regulating the operation of motor vehicles on Front Street. He stated that the state of traffic on Front Street was such as to be very dangerous to pedestrians crossing the highway. It was moved by Shrock and seconded by Wills that L.A. Maple be hired for a period of one month as a traffic officer at a salary of \$25.- and that the Recorder pay Mr. Maple out of fines collected. Motion carried and so ordered.

It was moved by Dell and seconded by Shrock that the following bills be approved and that the Recorder issue warrants covering the same.

The four hundred twelfth regular meeting of the Council of Milwaukie was held on the 27th day of January, 1936

The meeting was called to order by Mayor Sanders.

Present: Mayor Sanders; Councilmen Burdick, Dell, Shrock, Walsh and Wills; Marshal Riley, Water Superintendent Bevington, Fire Chief Lewellyn and Recorder Adams.

The manager of the local Safeway Stores, Inc. stated that his

company had paid the arrearages owed on beer licenses and asked that the matter of his company's application for a recommendation that a package beer license be granted it be considered. It was moved by Shrock and seconded by Dell that the matter of Safeway Stores, Inc. application for a recommendation concerning a beer license be taken up. Motion carried and so ordered.

It was moved by Dell and seconded by Walsh that the Council recommend that a package beer license be granted to Safeway Stores, Inc. Motion carried and so ordered.

It was moved by Walsh and seconded by Shrock that a chemical analysis and bacterial analysis be secured of the water from the test well. Motion carried and so ordered.

It was moved by Dell and seconded by Walsh that the Street Commissioner be authorized to repair the roadways of the streets. Motion carried and so ordered.
