

TOWN HALL, MILWAUKIE, OREGON, FEB. 9TH. 1926.

The two hundred eightyseventhregular meeting of the Council of the Town of Milwaukie was held on the 9th. day of February, 1926.

Meeting called to order by Mayor Cowell. Present, Mayor Cowell, Councilmen, Ramsey, Kerr, Grasle, McIntyre and Hazen, Recorder Mathews and Marshal Keck. The minutes of the two hundred eighty-sixth regular meeting of the council held on the 12th. day of Jan. 1926, and the minutes of the adjourned meeting of the two hundred eighty-sixth regular meeting of the Council held on the 26th. day of January, 1926, also the minutes of the special meeting of the Council held on the 29th. day of January, 1926, were read and approved as read. Upon motion duly made and carried, Ordinance No. 238 entitled, " An ordinance prohibiting the transportation of manure or fertilizer of an obnoxious or offensive odor in and through the Town of Milwaukie, Oregon, unless the same shall be securely covered, and providing a penalty for the violation of the provisions of this ordinance", was taken up for the first reading. The ordinance being read the roll-call showed the following result: Ayes: Ramsey, Kerr, Grasle, McIntyre and Hazen. Nays, none. Ordinance No. 238 passed the first reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 238 was taken up for the second reading and read by title only. The roll call showed the following result: Ayes, Ramsey, Kerr, Grasle, McIntyre and Hazen. Nays, none. Ordinance No. 238 passed the second reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 238 was taken up for the third and final reading and read by title only. The rollcall showed the following result: Ayes, Ramsey, Kerr, Grasle, McIntyre and Hazen. Nays, none. Ordinance No. 238 passed the third and final reading. Upon motion duly made and carried, Ordinance No. 239 entitled, " An ordinance regulating blasting and the exploding of gunpowder, dynamite, giant powder, gun cotton, or other explosives in the Town of Milwaukie, Oregon, for the purpose of blasting out rock, gravel, earth or other substance; providing a penalty for the violation of the provisions of this ordinance, and repealing all ordinances and parts of ordinances in conflict herewith," was taken up for the first reading.

The ordinance being read the roll-call showed the following result: Ayes, Ramsey, Kerr, McIntyre, Grasle and Hazen. Nays, none. Ordinance No. 239 passed the first reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 239 was taken up for the second reading and read by title only. The roll-call showed the following result: Ayes, Ramsey, Kerr, Grasle, McIntyre and Hazen. Nays, none. Ordinance No. 239 passed the second reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 239 was taken up for the third and final reading and read by title only. The roll-call showed the following result: Ayes, Ramsey, Kerr, McIntyre, Grasle and Hazen. Nays, none. Ordinance No. 239 passed the third and final reading. A. Glover, F. Glover and Mr. Mason were present and asked the Council upon what condition that Milwaukie would take over their several water systems. Upon motion duly made and carried, the matter was postponed until next meeting of the Council. Upon motion duly made and carried, it was ordered that the Town of Milwaukie take over the water main of Mr. Linskey. The proposals for the sale of lots 23 & 24 Block "B" Kerr and Shindler Addition were opened and read which proposals were as follows: John Shields-\$500.00, Milwaukie to pay Liens and interest. Purchase price to be paid in installments monthly: S. W. Webber-\$125.00 cash, and assume City liens and interest: Charles W. Davis-\$400.00. \$150.00 cash, balance to be paid in monthly installments of \$30.00 each, with interest at rate of 6% per annum. Upon motion duly made and carried, lots 23 & 24 in Block "B" Kerr & Shindler Addition, was sold to Chas. W. Davis for \$400.00, the said Chas. W. Davis to assume the city liens against the property. Mr. Leo Johnson was present and advised the Council that Fire Chief Mullan would quit as Fire Chief on March 1st. 1926, if his salary was not increased. Upon motion duly made and carried, the matter was laid on the table until February 16th. 1926.

Moved by councilman Ramsey and seconded by councilman Hazen that the Recorder be instructed to notify Mr. Toates and Mr. Hazelton if they did not remove the dirt in front of their property within 5 days that they would be arrested. Motion withdrawn. Upon motion duly made and carried, the Street Supt. was instructed to see that Mr. Toates and Mr. Hazelton remove the dirt from the street in front of their property. The matter of taking over the water system of Mrs. Derry was referred to Water Committee. The following bills were read and allowed by the Finance Committee, and upon motion duly made and carried, the Recorder was instructed to draw warrants in payment of the same:

An adjourned meeting of the two hundred eighty-seventh regular meeting of the Council was held on the 16th. day of February, 1926. Meeting called to order by Mayor Cowell. Present, Mayor Cowell, Councilmen, Ramsey, Kerr, Grasle, McIntyre and Hazen, Recorder Mathews and Marshal Keck. Mayor Cowell stated that the meeting was held for the purpose of considering the remonstrances filed against the construction of the proposed sewer. Upon motion duly made and carried, ordinance No. 240 entitled, " An ordinance regulating the barricading of streets in the Town of Milwaukie, Oregon, and the closing of streets or highways to travel, and providing a penalty of the violation of the provisions of this ordinance," was taken up for the first reading. The ordinance being read the roll-call showed the following result: Ayes, Ramsey, Kerr, Grasle, McIntyre and Hazen. Nays, none, Ordinance No. 240 passed the first reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 240 was taken up for the second reading and read by title only. The roll-call showed the following result: Ayes, Ramsey, Kerr, Grasle, McIntyre and Hazen. Nays, none. Ordinance No. 240 passed the second reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 240 was taken up for the third and final reading and read by title only. The roll-call showed the following result: Ayes, Ramsey, Kerr, Grasle, McIntyre and Hazen. Nays, none. Ordinance No. 240 passed the third and final reading. Moved by Councilman ~~Ramsey~~ *Kerr* and seconded by Councilman ~~Ramsey~~ *Kerr* that all proceedings in regard to the construction of the proposed sewer in Milwaukie be rescinded, whereupon Mr. Stafford ~~and Mr. Shaw~~ *requested* that the Council hear the remonstrances filed against the proposed sewer, which ~~request~~ *request* was refused. A vote being taken on the motion, the motion carried. Councilmen Ramsey, Kerr, McIntyre and Hazen voting for the motion and Councilman Grasle against the motion. Mr. Glover was present and informed the Council that he would not pay the increased water rates. Upon motion duly made and carried, the Water Committee and Water Supt. were instructed to inspect all water systems proposed to be turned over to the Town of Milwaukie, and report their findings to the Council. Mr. Toates was present and explained why the dirt in front of his property was not moved sooner, he also requested the Council to remove the Fire Hydrant off his property. Upon motion duly made and carried, the Council adjourned.
