

MEETING OF MARCH 12, 1956

COUNCIL CHAMBER

888th MEETING

The eight hundred eighty-eighth regular meeting of the Council was held on the twelvth day of March, 1956.

The meeting was called to order by Mayor Mullan.

Present: Mayor Mullan; Councilmen Clay, Perkins, Shook and Klein; Manager Burdick, Attorney Sheldahl and Recorder Martin. Absent: None.

The minutes of the eight hundred eighty-seventh regular meeting of the Council, held on the twenty-seventh day of February, 1956, were approved as written.

The matter of the improvement of 21st Street, by curbs, from Washington Street to Lake Road was again taken up. Manager Burdick reported that he was not finished with his investigation in the matter and requested that the time for investigation be extended until the next regular meeting of the Council.

Ordinance Number 636, AN ORDINANCE annexing certain territory contiguous to the present boundaries of the City of Milwaukie, Clackamas County, Oregon, and fixing the effective date of such annexation, was taken up and read for its second reading and put on its passage with the following result being had. Ayes: Mullan, Perkins, Clay, Shook and Klein. Nays: None. Ordinance Number 636 passed the Council and was so declared by the Mayor.

Ordinance Number 637 was taken up and read in full for its first reading. It was moved by Shook and seconded by Perkins that Ordinance No. 637 be passed to its second reading. Motion carried and so ordered.

The Police Chief's monthly report was read and ordered filed.

City Manager Burdick reported progress in street repairs, also that there were many inquiries on annexation from property owners adjacent to the City, especially interested are property owners east of the City.

Attorney Sheldahl reported the status of the George Kirkpatrick VS the City of Milwaukie, case.
