

TOWN HALL, MARCH 5TH. 1918.

The one hundred ninety-second regular meeting of the Council of the Town of Milwaukie was held on the above named date. Meeting call to order by Mayor Snyder. Present, Mayor Snyder, Councilmen Shindler, Grasle, Miller, Pates and Seavey, Recorder Mathews, Treasurer Streib and Marshal Riley. The minutes of the one hundred ninety-first regular meeting of the Council held on the 5th day of February, 1918, and the minutes of the special meeting held on the 28th day of February, 1918, were read and approved as read.

A resolution exempting the Oceanic Shipbuilding Company from City taxes was read and upon motion of councilman Miller seconded by councilman Pates and carried, the resolution was laid on the table temporarily. Upon motion duly made and carried Ordinance No. 159 was taken up for the first reading. The ordinance being read the roll call showed the following results; Ayes, Grasle, Miller, Pates and Seavey. Nays, none. Councilman Shindler refused to vote. Ordinance No. 159 passed the first reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 159 was taken up for the second reading and read by title only. The roll call showed the following result: Ayes, Grasle, Pates, Miller and Seavey. Nays, none, Ordinance No. 159 passed the second reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 159 was taken up for the third and final reading and read by title only. The roll call showed the following result: Ayes, Grasle, Miller, Pates and Seavey. Nays, none. Ordinance No. 159 passed. The application of Frank Savitale for a pool room license was read and upon motion duly made and carried, the Recorder was instructed to grant him a pool room license, provided that he would cut the window down to not less than three feet from the floor and put in clear glass. Upon motion duly made and carried, the Marshal was given charge of the city hall and instructed to attend all meetings held therein and to hire a carpenter to make the necessary repair to the Hall. The Recorder was instructed to furnish the Council with a list of all delinquent property for Street assessments. Upon motion duly made and carried, Mr. Counsell was asked to give an estimate of what it would cost to repair, redress and reroll the streets.

The following bills were read and allowed by the Finance Committee and upon motion duly made and carried, the Recorder was instructed to draw warrants on the City Treasurer in payment of the same:

An adjourned meeting of the one hundred ninety-second meeting of the Council was held on the above named date. Meeting called to order by Mayor Snyder. Present, Mayor Snyder, Councilmen, Shindler, Grasle, Miller, Pates and Seavey, Recorder Mathews and Marshal Riley. The application of Wolfer and Brown for a pool room license was read and upon motion duly made and carried, the Recorder was instructed to grant Wolfer & Brown a pool room license.

Ordinance No. 160 was read and upon motion duly made and carried, the Recorder was instructed to post a copy of the same as required by the City Charter. Moved by councilman Miller and seconded by councilman Pates that P. G. Skulason be employed to defend the Town in the case of Montague-C'Reilly Co. vs. Town of Milwaukie. Motion lost. Upon motion duly made and carried, Mr. Mathews and Mr. Pates were instructed to see Mr. Houston and get an opinion from him as to whether or not Montague-C'Reilly Co. could recover from the Town. Upon motion duly made and carried, the Treasurer was authorized to purchase ~~###~~ what stationery he needs for the water Dept. The following bills were read and allowed by the Finance Committee and upon motion duly made and carried, the Recorder was instructed to draw warrants in payment of the same:

Mathews was employed to defend the Town in the case of Montague-C'Reilly Co. vs. Town of Milwaukie, and to secure such legal assistance as he may deem necessary, and his fee to be \$500.00.

Upon motion duly made and carried, the Council adjourned until the 19th day of March, 1918.

An adjourned meeting of the Council was held on the above named date. Meeting called to order by Mayor Snyder. Present, Mayor Snyder, councilmen, Grasle, Bates, Miller and Seavey, Recorder Mathews and Marshal Riley. Ordinance No. 161 regulating dance halls and dancing in the Town of Milwaukie was read and a copy ordered posted as required by the City Charter. Mr. Risley was present and explained to the Council how he intended to expend the County Road money in Milwaukie. A communication from Mr. Houston explaining his former letter to the Council was read and ordered placed on file.

Town Hall, Milwaukie, Oregon, April 2nd. 1918.

The one hundred ninety-third regular meeting of the Council was held on the 2nd. day of April, 1918. Meeting called to order by Mayor Snyder. Present, Mayor Snyder, Councilman, Shindler, Grasle, Miller, Bates and Seavey, Recorder Mathews, Marshal Riley and Treasurer Streib.

The minutes of the one hundred ninety-second regular meeting of the Council held on the 5th day of March, 1918, and the minutes of the adjourned meetings of the one hundred ninety-second regular meeting held on the 8th, 14th and 19th days of March, 1918, were read and approved as read. Mr. Robinson representing the War Dept. was present and explained to the Council the necessity of passing an ordinance regulating dance halls and dancing in the Town of Milwaukie. Representatives of the Portland Pulley Company was present and requested the Council to donate \$2000.00 to the Company in order to get them to locate in Milwaukie, Oregon. The matter was taken under advisement. Upon motion duly made and carried, the Marshal was instructed to notify all property owners against whose property there are delinquent assessments that unless the delinquent assessments are paid within ten days from receipt of notice that the Marshal would proceed to sell such property to pay the same. Mr. Wolfer was present and asked the Council to modify the Ordinance regulating pool rooms in order that he could operate his pool room on Sundays. The matter was taken under consideration until the next meeting. The report of the Treasurer was read and ordered placed on file. The Marshal was instructed to notify the persons operating a pool room in the Frank Arighi Building to secure a license and comply the ordinance regulating pool rooms and if they did not do so to close the same. The matter of cultivating the vacant city lots was turned over Mrs. Johnson and the Parent-Teachers Association. The following bills were read and allowed by the Finance Committee and upon motion duly made and carried, the Recorder was instructed to draw warrants on the City Treasurer in payment of the same:
