

TOWN HALL, MILWAUKIE, OREGON, MARCH 7TH. 1922.

The two hundred fortieth regular meeting of the Council of the Town of Milwaukie, was held on the 7th day of March, 1922. Meeting called to order by Mayor Snyder. Present, Mayor Snyder, councilmen, Albee, Miller, Shindler and Counsell, Recorder Mathews, Treasurer Streib and Marshal Keck. The minutes of the two hundred thirty-ninth regular meeting of the Council hold on the 18th day of February, 1922, and the minutes of the special meeting of the Council held were read and approved as read. Mr. Counsell reported that he had finished gravelling R. R. Avenue. The light Committee reported that they had taken the matter of removing the arc light from the old tavern to 30th & Sellwood Streets with the P. R. L. & L. Co. and that the Company had promised to make an estimate of removing the same, but had not done so. The Viewers on the proposed extension of Harrison Street reported that they were not ready to make a report of said extension and that they desired the assistance of the Engineer to aid them in making up the assessment roll. Upon motion duly made and carried, the City Engineer was instructed to assist the Viewers in making their report. Upon motion duly made and carried, the Mayor was granted the use of the Council Chambers for Wednesday night the 8th day of March, 1922. Upon motion duly made and carried, the Recorder was instructed to draw a warrant in favor of the First State Bank for \$150.00 to make up the deficit of the 32nd. Street improvement.

Upon motion duly made and carried, the Mayor was authorized to appoint a committee to find out what it would cost to have the City Books audited. The Mayor appointed Mr. Miller and Mr. Albee as such committee.

TOWN HALL, MILWAUKIE, OREGON, MARCH, 22nd. 1922.

An adjourned meeting of the two hundred fortieth regular meeting of the Council was held on the above named date. Meeting called to order by Mayor Snyder. Present, Mayor Snyder, Councilmen, Miller, hart Shindler, Albee and Counsell, and Marshal Keck. Dr. Stewart and others were present and protested to the Council against allowing garbage and other rubbish being dumped at the foot of Washington Street, upon motion duly made and carried, the matter was referred to the Street Committee.

A petition of some of the citizens on Washington Street protesting against the piling of wood and machinery in said street was read and the Marshal was instructed to abate the nuisance. The Viewers appointed to assess benefits and damages on the proposed extension of Harrison Street having filed their report with the Recorder, upon motion duly made and carried, the 10th day of April, 1922, at the hour of 8:00 o'clock P. M. of said day as the time and the City Hall as the place for considering said report and hearing objections thereto, if any therebe. And the Recorder was further instructed to publish said report in a newspaper of general circulation in Milwaukie for once at least ten days before said hearing.

Upon motion duly made and carried, the Council adjourned.
