

TOWN HALL, MILWAUKIE, OREGON, MARCH 10TH. 1925,

The two hundred seventy-sixth regular meeting of the Council was held on the 10th day of March, 1925. Meeting called to order by Mayor Cowell. Present, Mayor Cowell, Councilmen Ramsey, Kerr, Kelso, McIntyre and Hazen, Recorder Mathews and Marshal Keck. The minutes of the two hundred seventy-fifth regular meeting of the Council held on the 10th day of February, 1925 and the minutes of the adjourned meeting of the two hundred seventy-fifth regular meeting of the Council held on the 26th day of February, 1925, were read and approved as read. Upon motion duly made and carried, the City Engineer was instructed to make a preliminary estimate of the cost of improving 32nd. Street from Harrison Street north to the city limits. Ordinance No. 221 entitled, "An ordinance authorizing the issuance of improvement bonds pursuant to the provisions of the Charter of the Town of Milwaukie, Oregon, and sections 3788 to 3796, both inclusive, of Oregon Laws, and declaring an emergency" was read and upon motion duly made and carried, the ordinance was ordered posted as required by the city Charter. A petition of property owners requesting the Council to have the grade on Jackson Street remain as was established by the original survey of the Minthorn Addition was read and upon motion duly made and carried, the request was granted.

Ordinance No. 222 was read and ordered posted as required by the City Charter. Upon motion duly made and carried, the Recorder was instructed to prepare an ordinance regulating the sale of milk in Milwaukie. The Street Supt. was instructed to run the grader over all the Streets that need grading.

The Street Committee was instructed to request the Southern Pacific Company to provide a wig wag or automatic bell signal at its railroad crossing on Harrison Street. The following bills were read and allowed by the Finance Committee and upon motion duly made and carried, the Recorder was instructed to draw warrants in payment of the same:

TOWN HALL, MILWAUKIE, OREGON, MARCH 16TH. 1925.

An adjourned meeting of the two hundred seventy-sixth regular meeting of the Council held on the 10th. day of March, 1925, was held on the 16th day of March, 1925. Meeting called to order by Mayor Cowell. Present, Mayor Cowell, Councilmen Hazen, McIntyre, Kelso, Kerr and Ramsey, Recorder Mathews and Marshal Keck. A petition signed by 185 voters of the Town of Milwaukie requesting the Council to call a special city election for the purpose of voting a bond issue of \$35,000.00 for improving the following streets with hard surface pavement sixteen feet in width: Washington Street from 27th street to Elmer Street; Elmer street to Oak Street; Oak Street to East Monroe Street; East Monroe Street from Oak Street to 42nd. Street; Harrison Street to 42nd. Street, and 32nd. Street, was read, and upon motion duly made and carried, was granted except that 32nd. Street be paved only from Harrison Street north to city limits. Upon motion duly made and carried, the Recorder was instructed to prepare the necessary amendment to the City Charter authorizing the Council to issue \$35,000.00 general obligation bonds to pay for said paving and to conduct the proceedings of the special election, and render a bill for his services to the Council. Councilman Kelso was instructed to look after the Jackson Street improvement. The request of Mr. Bradley for permission to build a shed back of the fire Station was referred to the Fire Committee. Upon motion duly made and carried, the Council adjourned until Tuesday the 31st day of March, 1925.
