MEETING OF APRIL 13, 1953

## 818th MEETING

The eight hundred eighteenth regular meeting of the Council was held on the thirteenth day of April, 1953

The meeting was called to order by Mayor Mullan

Present: Mayor Mullan, Councilmen Shook, Clay, Klein and Wright; Manager Sperr, Attorney Kirkpatrick, Fire Chief Lillis, Police Chief Delp and Recorder Martin.

The matter of vacating a portion of Adams Street in Minthorn Addition was again laid before the Council. It was moved by C Clay and seconded by Wright that that portion of Adams Street which lies west of 37th Street Minthorn Addition be vacated. Motion carried and so ordered.

Ordinance Number 579 AN ORDINANCE requiring a license from all persons engaged in revealing or attempting to reveal the future events in another's life; setting up standards for qualifying for such license; requiring a bond from all persons so engaged and providing a penalty for the violation hereof, was taken up and read in full for its second reading and put on its passage with the following results being had. Ayes: Mullan, Shook, Clay, Klein and Wright. Nays: None. Ordinance Number 579 passed the Council and was so declared by the Mayor.

The matter of the water stand-by charge to Western Door and Plywood was discussed. Western Door and Plywood had advanced the funds for installing the large main from 32nd and Harvey to their plant at 31st and Meel Streets. The City was to repay them by crediting the stand-by charges and water costs. On or about April 1, the Western Door and Plywood Co. changed ownership and have called upon the City for the balance due them in the amount of \$2,841.04. Manager Sperr reported that he and Attorney Kirkpatrick had gone over the figures with Messrs. Morris owners of Western Door and Plywood, and that they had waived the 4% interest on moneys owed by the City, the City waived the difference between a ten-inch and eight inch main for the stand-by charge. It was moved by Klein and seconded by Wright that the City charge Western Door and Plywood for ten inch stand-by charge which would amount to \$66.00 per month, but that the Western Door and Plywood Co. be allowed, on account of interest of their investment in the pipe line, in the sum of \$25.00 per month

making the net charge of \$41.00 per month; and that the City Treasurer be authorized to pay the Western Door and Plywood the sum of \$2841.04 in full settlement with said Western Door and Plywood Co. and that the Milwaukie Plywood & Door Co. be charged for stand-by service on the basis of ten inch service at \$66.00 per month. Motion carried and so ordered.

A petition, requesting that 37th Street, between Harrison Street and King Road be improved by curbs and sidewalks, was read. The petition was signed by 100 percent of the property owners. There was discussion about extending the improvement south to Monroe Street. It was decided that this petition be not acted upon at this meeting, and that before the next meeting the owners of the property along 37th Street from Harrison Street to Monroe Street be contacted on the matter of putting in curbs and sidewalks along that section of the street.

A petition, signed by the property owners along 32nd Street, between Elmer and Wister Streets, asking that curbs and sidewalks be put in along this street, was read. It was moved by Klein and seconded by Shook that the Engineer prepare estimates of costs and that the Attorney prepare a resolution for the improvement of 32nd Street Quincy Addition, by curbs and sidewalks from Elmer to Wister Streets. Motion carried and so ordered.

A delegation of Volunteer Firemen appeared before the Council and requested that the Volunteers be paid at the rate of \$1.00 per meeting attended and \$1.00 per fire in which they participate in fighting. The delegation were advised to appear before the Budget Committee and present their proposition.

Dr. James B. Harrison came before the Council and requested to buy a plot of ground, in Kellogg Park, south of the Sewage Disposal Plant, and owned by the City. Dr. Harrison's request was for 150 feet frontage on River Road and a depth of 100 feet, and his intention is to place a veterinarian hospital on the property. The Council requested Dr. Harrison to present a bid for the property.

A letter from Dr. E.T. Hedlund, Postmaster, in which he requested that a portable sign "U.S.MAIL NO PARKING" be permitted to be placed, by them, at their discretion, in front of the Milwaukie Post Office. In as much as the Post Office already has a "LOADING ZONE" sign which they use, the Council decided, after some discussion, that the "LOADING ZONE" sign should be sufficient for their use.

A letter from School Board No. 1 was read. The letter stated that the Board felt that the \$17.80 assessed to them for engineering costs of improvement of 27th Street from Washington Street to Luke Road, should be excused. It was moved by Wright and seconded by Shook that the School be not excused from paying the assessment. Motion carried and so ordered.

Manager Sperr reported that the new alarm bell at the Oak Street crossing had been silenced by Southern Pacific Co. to ring a maximum of two minutes.

It was moved by Clay and seconded by Wright that the following Resolution be adopted.

RESOLUTION NUMBER 5-1953

WHEREAS in the interest of safety it is necessary to make the following changes in traffic regulations pursuant to Ordinance Number 530

## BE IT THEREFORE RESOLVED:

1. That parking of vehicles be prohibited on the north side of Monroe Street from 29th Street to 28th Street; this to be in addition to the present no parking regulations on said Monroe Street.
2. That all parallel parking be prohibited on all streets where diagonal parking has heretofore been established.
3. That all U turns be prohibited on Main Street from Harrison Street to Washington Street, both inclusive.
4. That all U turns be prohibited on 21st Street from Harrison Street to Washington both inclusive.

That this resolution be effective from the time that suitable markers or other proper identification of these changes are established.

Manager Sperr reported that the Board of the Milwaukie Rural Fire Protection District had reported to him that they would raise their fee to the City in an amount of 6% of their present fee. It was decided that investigation into this matter be made. *Rural Fire Dist*

Manager Sperr reported that the Fire Department Tank Truck was leaking. After some discussion the Council agreed that the Tank Truck be repaired.

Attorney Kirkpatrick reported that on May 12, there would be a meeting of Road District No. 4.

It was moved by Wright and seconded by Shook that the City's share of the cost of improvement of 27th Street from Washington Street to Lake Road, in an amount of \$1,313.12 be authorized to be paid. Motion carried and so ordered.

It was moved by Shook and seconded by Klein that the Recorder be authorized to accept a note signed by the property owner as payment for the improvement of 27th Street from Washington Street to Lake Road, said note to have a maximum time limit of two years and a minimum payment of \$10.00 per month plus interest on any unpaid balance. Motion carried and so ordered.

The Police Chief's monthly report was read and ordered filed.

It was moved by Shook and seconded by Klein that the following bills be paid and that the Recorder be directed to issue warrant-checks for the payment of same.
