An adjourned meeting of the two eighty-ninth regular meeting of the Council of Milwaukie was held on the above named date. Meeting called to order by Mayor Cowell. Present, Mayor Cowell, Councilmen; Ramsey, Kerr, Frey and Hazen, Recorder Mathews and Marshal Keck. There being no remonstrances filed against the proposed Washington-Elmer and 32nd Streets sewer, Upon motion of Councilman Frey duly seconded by councilman Kerr, the Recorder was instructed to prepare an ordinance providing for the construction of said sewer and post the same as required by the City Charter. Upon motion duly made and carried, Ordinance number 242 entitled "An ordinance providing for the construction of certain sewers in the Town of Milwaukie, Oregon, and declaring an emergency," was taken up for the first reading. The ordinance being read the roll-call showed the following result: Ayes, Ramsey, Kerr, Frey and Hazen. Noes, none. Ordinance No. 242 passed the first reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 242 was taken up for the second reading and read by title only, the Roll-call showed the following result: Ayes, Ramsey, Kerr, Frey and Hazen. Noes, none. Ordinance No. 242 passed the second reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 242 was taken up for the third and final reading and read by title only. The roll-call showed the following result: Ayes, Ramsey, Kerr, Frey and Hazen. Noes, none. Ordinance No. 242 passed the third and final reading. Upon motion duly made and carried, the Recorder was instructed to advertise for bids for the construction of the sanitary sewer in the Daily Journal of Commerce, said bids to be opened on the 29th. day of April, 1926. Upon motion duly made and carried, the Council adjourned until the 29th. day of April, 1926.

An adjourned meeting of the two hundred eighty-ninth regular meeting of the Council was held on the 29th. day of April, 1926. Meeting called to order by Mayor Cowell. Present, Mayor Cowell, Councilmen; Ramsey, Kerr, Grasle, Frey and Hazen, Recorder Mathews and Marshal Keck. Upon motion duly made and carried, it was ordered that the Town of Milwaukie furnish all water for back filling needed in the construction of all sewers in Milwaukie. There being no objections filed or made to the acceptance of the improvement of 28th Street and Lake Road, upon motion duly made and carried, the improvement of 28th. Street and the improvement of Lake Road were accepted. Upon motion duly made and carried, the proposals for the construction of the sanitary sewer were opened and read, which bids were as follows:

Upon motion duly made and carried, Peterson & Scott were awarded the contract for the construction of the sanitary sewer according to their bid for vitrified sewer pipe.

Upon motion duly made and carried, the Recorder was instructed to return to the unsuccessful bidders the certified checks accompanying their bids.

Upon motion duly made and carried, the mayor and recorder were instructed and directed to execute a contract on behalf of the Town of Milwaukie with Peterson and Scott for the construction of the sanitary sewer at the rates specified in their bid. It was ordered that Peterson & Scott furnish a bond of 75% of the amount of their bid.

Upon motion duly made and carried, the Council adjourned.
