

Milwaukie, Oregon, May 7th. 1918.

The one hundred ninety-fourth regular meeting of the Council of the Town of Milwaukie was held on the above named date. Meeting called to order by Mayor Snyder. Present, Mayor Snyder, councilmen Shindler, Miller and Bates, Recorder Mathews, Marshal Riley and Treasurer Streib. The minutes of the one hundred ninety-third regular meeting of the Council held on the 2nd day of April, 1918, and the minutes of the adjourned meeting of the one hundred ninety-third regular held on the 5th day of April, 1918, also the minutes of the special meetings of the council held on the 6th and 25th days of April, 1918, were read and approved as read. Moved by councilman Miller and seconded by councilman Bates that the Town of Milwaukie appropriate \$7.50 to purchase a flag to place on City Hall. Motion carried. Upon motion duly made and carried, the Water Supt. was instructed to lay a 3/4 inch water pipe to the office of the Oceanic Shipbuilding Co. Upon motion duly made and carried, \$125.00 was appropriated out of the City Treasury to open and improve 32nd Street, North of Harrison Street. The following bills were read and allowed by the Finance Committee and upon motion duly made and carried, the Recorder was instructed to draw warrants in payment of the same:

Town Hall Milwaukie, Oregon, June 4th. 1918.

The one hundred ninety-fifth regular meeting of the Council of the Town of Milwaukie was held on the above named date. Meeting called to order by Mayor Snyder. Present, Mayor Snyder, Councilmen, Shindler, Grasle, Miller, Bates and Seavey, Recorder Mathews and Marshal Riley. The minutes of the one hundred ninety-fourth regular meeting held on the 7th day of May, 1918, was read and approved as read. Upon motion of councilman Miller duly made and carried, Charles Counsell was instructed to borrow or hire the grader from the County and grade up several blocks of streets in Milwaukie and try it out, and that \$100.00 be appropriated for that purpose. The petition of Edward G. Smith for a pool room license to conduct a pool room in the Gratton Hotel was read and upon motion duly made and carried the Recorder was instructed to issue a pool room license to Mr. Smith. Upon motion of Councilmen Miller duly made and carried, the recorder was instructed to send a bill for \$5.00 to the Multnomah Amateur Athletic Club for dancing permit. Upon motion duly made and carried, the dancing permit fee of \$5.00 due the Town from the Auxillary of Batteries A. and B. was remitted. The recorder was instructed to notify the property owners on Washington Street between Front Street and Main Street to repair the sidewalk adjacent to their property. Moved by councilman Grasle and seconded by councilman Seavey that the salary of the Recorder and marshal be raised each \$10.00 per month. Motion withdrawn. Upon motion of councilman Shindler duly seconded by councilman Grasle and carried, the Recorder salary was raised to \$40.00 per month. Moved by councilman Grasle and seconded by councilman Bates that the salary of the Marshal be raised \$10.00 per month.
