

TOWN HALL MILWAUKIE, OREGON, MAY 18TH. 1915.

A special meeting of the Town Council of the Town of Milwaukie was held on the above named date. Meeting called to order by Mayor Pelton. Present, Mayor Pelton, councilmen Grasle, Bond, Peery, Counsell and Skulason, Recorder Mathews and Marshal Riley. Mayor Pelton stated that the meeting was called for the purpose of taking up the proposed ordinance granting to the Portland Gas & Coke Company a franchise to lay gas mains in the Town of Milwaukie. Upon motion duly made and carried, ordinance No. 128 entitled "An ordinance granting to the Portland Gas & Coke Company, a corporation, its successors and assigns for a period of twenty-five (25) years, the right, privilege, and franchise to lay, maintain, and operate gas mains, pipes, and conduits with all necessary or desirable appurtenances, in and upon the present and future streets, alleys, and public highways of said Town of Milwaukie, and its successors, for the purpose of supplying gas to the said Town of Milwaukie, and its successors, and to the inhabitants thereof, and to persons living beyond the limits thereof, for light, heat, power and other purposes," was read and a copy ordered posted as required by the City Charter. Upon motion duly made and carried, ordinance No. 129 entitled, "An ordinance authorizing the issuance of improvement bonds in pursuance of sections 3245, 3246, 3247, 3248, 3249, 3250, 3251, 3252 and 3253 Lord's Oregon Laws, and declaring an emergency," was read and a copy ordered posted as required by the City Charter. Upon motion duly made and carried, the Council adjourned.

TOWN HALL MILWAUKIE, OREGON, JUNE 8TH. 1915.

The one hundred fifty-ninth (159) regular meeting of the Town Council of the Town of Milwaukie, Oregon, was held on the above named date. Meeting called to order by Mayor Pelton. Present, Mayor Pelton, Councilmen, Grasle, Bond, Counsell and Skulason, Recorder Mathews, and Marshal Riley. The minutes of the one hundred fifty-eight regular meeting of the Council held on the 11th day of May, 1915, and the minutes of the special meeting of the Council held on the 18th day of May, 1915, were read and approved as read.

Councilman Grasle of the Street Committee stated the the Committee had nothing to report on the vacating of the J. R. Sellwood Addition.

A communication from A. F. Roberts in regard to oiling the streets was read and the Recorder was instructed to notify all the road oiling Companies that the Council would receive bids for oiling the Streets, said bids to be opened on the 15th day of June, 1915. The bids to be on the price per barrel and on the price per mile of streets oiled.

A communication from Commissioner Daly was read and ordered placed on file. A communication from the P. R. L. & P. Co. in regard to the cost of moving certain arc lights was read and upon motion of councilman Skulason seconded by councilman Bond and carried, the Recorder was instructed to notify the Company to move the arc lights referred to in its letter on the terms stated therein. The City Engineer stated that he had received the following prices on the Street Signs, to-wit: Bowen & Westphal \$0.40 each. Kelly Advertising Co. \$0.35 each. The Engineer also stated that the city of Portland was getting street signs at \$0.29 each from some Company in the East by purchasing in large quantities. Upon motion duly made and carried, the Engineer was instructed to correspond with the firm in the East in regard to the prices of street signs and if they did not make any better prices than Kelly Advertising Co. to purchase the required number of signs from the Kelly Advertising Company. Upon motion duly made and carried, Ordinance No. 130. entitled "An ordinance vacating certain parts of the J. R. W. Sellwood Addition to the Town of Milwaukie", was read and a copy ordered posted as required by the City Charter.

Upon motion duly made and carried, ordinance No. 129 was taken up for the first reading. The ordinance being read the roll-call showed the following results: Ayes, Grasle, Bond, Counsell and Skulason. Nays, None. Absent, Peery. Upon motion duly made and carried, the rules were suspended and ordinance No. 129 was taken up for the second reading and read by title only. The roll-call showed the following results: Ayes, Grasle, Bond, Counsell and Skulason. Nays, none. Absent councilman Peery. Ordinance No. 129 passed the second reading. Upon motion of councilman Grasle seconded by councilman Skulason and carried, the rules were suspend and ordinance No. 129 was taken up for the third and final reading and read by title only. The roll-call showed the following results. Ayes, Grasle, Bond, Counsell and Skulason. Nays, none. Absent Peery. Ordinance No. 129 passed. Upon motion of councilman Bond seconded by councilman Counsell and carried, Ordinance No. 128 was taken up for the first reading. The ordinance being read the roll-call showed the following result: Ayes, Grasle, Bond, Counsell and Skulason. Nays, none. Absent Peery. Ordinance No. 128 passed the first reading. Upon motion of councilman Counsell seconded by councilman Grasle and carried, the rules were suspended and ordinance No. 128 was taken up for the second reading and read by title only. The roll-call showed the following result: Ayes, Grasle, Bond, Counsell and Skulason. Nays,

None. Ordinance No. 128 passed the second reading. Upon motion of councilman Skulason seconded by councilman bond and carried, the rules were suspended and ordinance No. 128 was taken up for the third and final reading and read by title only. The roll call showed the following result: Ayes, Grasle, Rond, Counsell and Skulason. Nays, none. Absent Peery. Ordinance No. 128 passed. Upon motion duly made and carried, ordinance No. 127 was taken up for the first reading. The ordinance being read the roll call showed the following result: Ayes, Grasle, Rond, Counsell and Skulason. Nays, none. Absent Peery. Upon motion of councilman Grasle seconded by councilman Rond and carried, the rules were suspended and ordinance No. 127 was taken up for the second reading and read by title only. The roll call showed the following result: Ayes, Grasle, Rond, Counsell and Skulason. Nays, none. Ordinance No. 127 passed the second reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 127 was taken up for the third and final reading and read by title only. The roll-call showed the following result: Ayes, Grasle, Rond, Counsell and Skulason. Nays, None. Ordinance No. 127 passed. Upon motion of councilman Grasle seconded by councilman Skulason and carried, the Recorder was instructed to notify Mr. Carver to put the streets over which he has built the railroad track in the condition it was before being torn up, and if he failed to do so the Council would repair the same and charge the cost to him. Upon motion duly made and carried, Mr. Streib was instructed to connect the catch basin at the intersection of Monroe and Front Streets with his sewer and send the bill to the City. Mayor Pelton appointed Mr. Rond, Mr. Counsell and Mr. Grasle as a committee to investigate the advisability of providing more exits for the City hall.

The following bills were read and allowed by the Finance Committee and upon motion of councilman Counsell and seconded by councilman Skulason and carried, the Recorder was instructed to draw warrants in payment of the same:

TOWN HALL MILWAUKIE, OREGON, JULY 13TH. 1915.

The one hundred sixtieth (160) regular meeting of the Town of Council of the Town of Milwaukie was held on the above named date. Meeting called to order by Mayor Pelton. Present, Mayor Pelton, councilmen Grasle, Peery and Counsell, Recorder Mathews, Treasurer Streib, and Marshal Riley. The minutes of the one fifty ninth regular meeting held on June the 8th. 1915, and the minutes of the adjourned meeting held on the 15th day of June, 1915, were read and approved as read. The report of the Treasurer was read and ordered placed on file. The application of Lyn W. Morgan for the position of water superintendent was read and placed on file. Upon motion duly made and carried, the Street Commissioner was instructed to repair the street in front of Mrs. Ganiard property and charge the cost of the same to the Oregon City and Portland Railway Company. Upon motion duly made and carried, the recorder was instructed to prepare an ordinance regulating the rate of speed of automobiles and motor-cycles in the corporate limits of the Town of Milwaukie, and post a copy of the same as required by the city charter. Upon motion of councilman Counsell seconded by councilman Grasle and carried, the recorder was authorized to purchase the necessary stationery for indexing the ordinances of the City.
