Present, Mayor Elmer, Councilmen, Counsell, Albee and Davis, Recorder Mathews and Marshal Reed. Upon motion of councilman Davis seconded by councilman Albee and carried, the meeting adjourned until 8 P. M. June 12th 1913.

Town Hall, Milwaukie, Oregon, June 12th 1913.

An adjourned meeting of the one hundred thirty-fifth regular meeting was held on the above named date. Meeting called to order by Mayor Elmer. Present: Mayor Elmer, councilmen, Davis, King, ~~xxxxxxx~~, Albee and Counsell, Recorder Mathews, Treasurer Bolstad and Marshal Reed.

The minutes of the one hundred and thirty-fourth meeting of the council held on May 13th 1913, and the call meetings of the Town Council held on the 19-21 and 27th days of May, 1913, and also the minutes of the call meeting held on the 4th day of June, 1913, were read and approved as read. The petition for the removal of the arc-light from the Milwaukie Tavern to the bridge across Johnson Creek was read and upon motion of councilman Counsell seconded by councilman Davis and carried, the petition was referred to the Light Committee.

Upon motion of councilman Albee seconded by councilman Counsell and carried Ordinance No. 87 was taken up for the first reading. The Ordinance being read the roll-call showed the following results: Ayes, xxxxxxxx King, Davis, Counsell and Albee: Nays, none. Ordinance No. 87 passed the first reading. Upon motion of councilman King seconded by councilman Davis and carried, the rules were suspended and ordinance No. 87 was taken up for the second reading and read by title only. The Roll-call showed the following results: Ayes: King, Counsell, Albee and Davis. Nays: None. Absent, Mitchell. Ordinance No. 87 passed the second reading. Upon motion of council Davis seconded by council Counsell and carried, the rules were suspended and ordinance No. 87 was taken up for the third and final reading and read by title only, whereupon the roll-call showed the following results: Ayes, King, Counsell, Davis and Albee. Nays: None. Absent Mitchell. Ordinance No. 87 passed.

Upon motion of councilman Albee seconded by Councilman Davis and carried, the recorder was instructed to advertise for bid for the improvement of Front Street in the Portland Daily Abstract for a period of 10 days. A petition for the improvement and widening of Monroe Street was read and upon motion of Councilman King seconded by councilman Counsell and carried, the petition was laid on the table.

A petition of the property owners along Monroe Street for the improvement of said Street was read and upon motion of councilman Counsell seconded by councilman Albee and carried, the petition was accepted and the City Engineer was instructed to make plans and specifications for an appropriate improvement of said street, and estimates of the work to be done and the probable costs thereof.

A petition of the property owners on De Witt Street for the improvement of the same was read, and upon motion of councilman Davis seconded by councilman Albee and carried, the petition was accepted and the City Engineer was instructed to make plans and specifications for the improvement of said street, together with estimates of the work to be done and the probable cost thereof. The application of Cy Confer and DeGrouchey for a saloon license was read and upon motion duly made and carried, the application was laid on the table. The application of A. J. Burns for a liquor license was also read, and upon motion duly made and carried was laid on the table.

An ordinance granting Stephen Carver the right of way for a railroad over certain streets in Milwaukie was read and upon motion of councilman Albee seconded by councilman Davis and carried the ordinance was laid on the table. Moved and seconded that the meeting adjourn until 7:30 P. M. Tuesday, June 17, 1913, Carried.
