TOWN HALL MILWAUKIE, OREGON, JULY 13TH. 1915.

The one hundred sixtieth (160) regular meeting of the Town of Council of the Town of Milwaukie was held on the above named date. Meeting called to order by Mayor Pelton. Present, Mayor Pelton, councilmen Grastle, Peery and Counsell, Recorder Mathews, Treasurer Streib, and Marshal Riley. The minutes of the one fifty ninth regular meeting held on June the 8th. 1915, and the minutes of the adjourned meeting held on the 15th day of June, 1915, were read and approved as read. The report of the Treasurer was read and ordered placed on file. The application of Lyn W. Morgan for the position of water superintendent was read and placed on file. Upon motion duly made and carried, the Street Commissioner was instructed to repair the street in front of Mrs. Ganiard property and charge the cost of the same to the Oregon City and Portland Railway Company. Upon motion duly made and carried, the recorder was instructed to prepare an ordinance regulating the rate of speed of automobiles and motor-cycles in the corporate limits of the Town of Milwaukie, and post a copy of the same as required by the city charter. Upon motion of councilman Counsell seconded by councilman Grastle and carried, the recorder was authorized to purchase the necessary stationery for indexing the ordinances of the City.

Upon motion duly made and carried, ordinance No. 130 was taken up for the first reading. TOWN HALL MILWAUKIE, OREGON, JULY 21st. 1915.

An adjourned meeting of the one hundred sixtieth (160) regular meeting of the Town Council was held on the above named date. Meeting called to order by Mayor Pelton. Present, Mayor Pelton, councilman Skulason, Peery and Grasley, Recorder Mathews and Marshall Riley. The Mayor was authorized to fix the rates for the use of the Roller. The following proposed amendment to the Charter of the Town of Milwaukie was read and upon motion duly made and carried, was ordered filed: "A Bill for an act to amend the Charter of the Town of Milwaukie, in the County of Clackamas, in the State of Oregon, by enacting and providing an amendment to said Charter, providing for and authorizing said Town of Milwaukie to issue and dispose of \$25,000.00 additional water bonds for the purpose of completing the Full Run Water System and installing water meters for each consumer.

BE IT ENACTED BY THE PEOPLE OF MILWAUKIE AND MILWAUKIE DOPS ORDAIN AS FOLLOWS:

Section 1. That the Charter of the Town of Milwaukie, in the County of Clackamas, in the State of Oregon, be and hereby is amended so as to authorize and empower the Town of Milwaukie to issue and dispose of \$25,000.00 additional water bonds for the purpose of completing the Full Run Water System under construction in said Town, and for purchasing and installing water meters for each consumer. The bonds to be in denominations of \$100.00 to \$1000.00, as the purchaser may desire and the Council deem best, with interest coupons attached thereto, the par value of which bonds shall not exceed the sum of \$25,000.00; said bonds to be signed by the Mayor and countersigned by the Recorder with the seal of the Town of Milwaukie affixed; whereby said Town of Milwaukie shall be held, bound and considered, in substance and effect, to undertake and promise, in consideration of the premises, to pay the bearer of each of said bonds, at the expiration of twenty years from date thereof, the sum therein named, in United States Gold Coin, with interest thereon at the rate not exceeding five per cent. per annum, payable semi-annually as provided in said coupons.

Section 2. The title of this Bill shall stand as the Title of the Act, should this Bill be enacted."
