An adjourned meeting of the one hundred-forty-eighth (148) regular meeting of the Town Council was held on the above named date. Meeting called to order by Mayor Elmer, present, Mayor Elmer, councilmen King, Mitchell Loeding and Albee, Recorder Mathews and Marshal Reed. Upon motion duly made and carried, Ordinance No. 112 was taken up for the first reading. The ordinance being read the roll-call showed the following results: Ayes, Mitchell, King, Loeding and Albee. Nays, none. Absent, Counsell. Ordinance No. 112 passed the first reading. Upon motion of councilman King seconded by councilman Loeding and carried, the rules were suspended and ordinance No. 112 was taken up for the second reading and read by title only. The roll-call showed the following results: Ayes, Mitchell, Loeding, King and Albee. Nays, none. Absent, Counsell. Ordinance No. 112. passed the second reading. Upon motion of councilman Loeding seconded by councilman Albee and carried, the rules were suspended and ordinance No. 112 was taken for the third and final reading and read by title only. The roll-call showed the following results; Ayes, Mitchell, King, Loeding and Albee. Nays, none. Absent, Counsell. Ordinance No. 112 passed the third and final reading. The application of Stephen Carver for a railroad franchise through Milwaukie was referred to the Council as a Committee of the Whole for consideration. After a recess Mr. Loeding, Chairmann of the Committee, reported that there were some provisions in the franchise that had not been agreed upon, and that the Committee would have it ready for the next meeting. Upon motion duly made and carried, the report of the Committee of the whole was adopted. There being no remonstrance against the improvement of Laurel Avenue, ordinance No. 115 providing for the improvement of the same was read and ordered posted as required by the City Charter. Upon motion duly made and carried the Council adjourned until the 31st day of July, 1914.

An adjourned meeting of the one hundred forty-eighth (148) regular meeting of the Town Council of the Town of Milwaukie was held on the above named date. Meeting called to order by Mayor Elmer. Present, Mayor Elmer, councilmen, King, Loeding Counsell, Albee and Mitchell, Recorder Mathews, and Marshal Reed. Upon motion of councilman Loeding seconded by councilman Counsell and carried the Recorder was instructed to notify the Lumbermens Trust Comapny, that on the account of being unable to have a full Council meeting, the council would not take up the ordinance issuing the water bonds until the regular meeting to be held on the 11th day of August, 1914. Upon motion of councilman Loeding seconded by councilman King and carried, the Treasurer was instructed to transfer 5% of the cost of the improvement of each street from the said street fund to the general fund.

Upon motion of councilman Albee seconded by councilman King and carried, the mayor and Recorder was instructed to enter into an agreement on behalf of the Town with Philip Streib granting the said Philip Streib 90 days in which to put in curbs along his property on Harrison Street.

Upon motion duly made and carried, the Council Adjourned.
