Town Hall, Milwaukie, Oregon, August 7th. 1917.

The one hundred eighty-fifth regular meeting of the Council was held on the above named date. Meeting called to order by Mayor Snyder. Present, Mayor Snyder, councilmen, Shindler, Grasle, Miller, Pates and Seavey, Recorder Mathews, Treasurer Streib and Marshal Riley. The minutes of the one hundred eighty-fourth regular meeting of the Council held on the 3rd day of July, 1917, and the minutes of the adjourned meeting of the one hundred eighty-fourth regular meeting held on the 16th day of July, 1917, were read and approved as read. Upon motion duly made and carried, the matter of cutting the obnoxious weeds within the Town of Milwaukie was referred to the Street Committee for attention, and the Recorder was instructed to write the Secretary of State for copies of State law in regard to cutting weeds. The matter of cleaning the Streets was referred to the Street Committee. The Recorder was instructed to notify Mr. Gibson that his water tank on Monroe Street was in a dangerous condition and to remove the same immediately. Upon motion duly made and carried, the Water Commissioner was instructed to install water meters for all consumers of bull run water who have not water meter installed. A communication from the Port of Portland refusing to dredge the Willamette River as petition for the the Town of Milwaukie and others was read and ordered placed on file.

A communication from Mrs. Sarah Solomonm requesting aid from the Council was read and Mayor Snyder appointed Mr. Grasle and Mr. Pates to take the matter up with the County Court of Clackamas County. Upon motion duly made and carried, the Water Committee was instructed to investigate the junk that is to be sold and report to the Council at the next meeting. The marshal was instructed to notify Mrs. John Stuckey to keep her dogs in the kennel or pay a separate license for each. The Recorder was instructed to have the deed from the Portland and Oregon City Railroad Company to the Town of Milwaukie recorded. A communication from Samuel Pearson requesting the Council to do what is necessary to make Duerest's Addition more sanitary by draining the same, and the Recorder was instructed to write to the Southern Pacific Co. and ascertain if they would lower their drain under Washington Street in order that the above property could be drained.

The alleged claim of A. C. Connelly against the Town for damages was disallowed. Upon motion duly made and carried, ordinance No. 156 was taken up for the first reading. The ordinance being read the roll-call showed the following result: Ayes, Shindler, Grasle, Miler, Pates and Seavey. Nays, none. Ordinance No. 156 passed the first reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 156 was taken up for the second reading and read by title only. The roll call showed the following result: Ayes, Shindler, Grasle, Miller, Pates and Seavey. Nays, none. Ordinance No. 156 passed the second reading. Upon motion duly made and carried, the rules were suspended and ordinance no. 156 was taken for the third and final reading and read by title only. The roll call showed the following result: Ayes, Shindler, Grasle, Miller, Pates and Seavey. Nays, none. Ordinance No. 156 passed. Upon motion duly made and carried, the Recorder was instructed to advertise for bids for the improvement of 31st Street in the Daily Record-Abstract said bids to be opened on the 21st day of August, 1917. Upon motion duly made and carried, the 21st day of August was the time set for hearing objections, if any, to the acceptance of the improvement of 21st Street. Upon motion duly made and carried, the matter of constructing a railing on 27th Street was left with the Street Committee.

Town Hall, Milwaukie, Oregon, August 21st. 1917.

An adjourned meeting of the one hundred eighty-fifth regular meeting of the Council was held on the above named date. Meeting called to order by Mayor Snyder. Present, Mayor Snyder, Councilmen, Shindler, Grasley, Miller, Fates and Seavey, Recorder Mathews and Marshal Riley. The bids submitted for the improvement of 31st Street were opened and read and were as follows:

Lindstrom Bros.....	3385.92.

Upon motion duly made and carried, all the bids were rejected and the Recorder was instructed to return the certified checks to the bidders. The Committee appointed to interview the County Court in regard to furnishing Mrs. Solomon County aid reported that they had an interview with Judge Anderson and that he ~~had promised~~ ^{had promised} to have the County pay her \$10.00 per month. There being no objections to the acceptance of the improvement of 27th Street, upon motion duly made and carried, the improvement of said street was accepted as completed by the contractor. Upon motion duly made and carried, the Recorder was instructed send Mr. Counsell a bill for \$23.50 for water used and a bill for \$50.00 for ten days use of the roller.

Moved by councilman miller and seconded by councilman Grasley that the railing on 27th Street be built on the plan submitted by Mr. Fates. Motion carried. Moved and seconded that the Lakewood Water users association be charged twenty cents per 100 cu. ft. for all the water used in the excess of 300 cu. ft. during the months of August and September of this year. Motion carried. Moved by councilman Fates and seconded by councilman Seavey that the office of Street and water Commissioner be declared vacant and that the council proceed to elect some competent person to fill the office. Motion withdrawn. The matter of having reports printed for the Street and Water Commissioner and marshal was referred to the Street Committee. The recorder was requested to notify Mr. Gibson that if he did not take care of his water tank on Monroe Street by the first of the month that the Council would take some action in regard to the matter. The following bills were allowed by the Finance Committee and upon motion duly made and carried, the recorder was instructed to draw warrants in payment of the same:
