

MEETING OF SEPTEMBER 14, 1953

COUNCIL CHAMBER

828th MEETING

The eight hundred twenty-eighth regular meeting of the Council was held on the fourteenth day of September, 1953

The meeting was called to order by Mayor Mullan.

Present: Mayor Mullan, Councilmen Shook, Clay and Klein; Manager Sperr, Attorney Kirkpatrick, Fire Chief Lillis, Police Chief Delp and Recorder Martin.
Absent: Councilman Wright.

The minutes of the eight hundred twenty-seventh regular meeting of the Council, held on the twenty-fourth day of August, 1953 were approved as written.

Mr. A. E. P. case, 3726 Jackson Street, appeared before the Council and requested that Jackson Street be graded and rocked. Manager Sperr reported that the street crew would be working on the street within the next two weeks.

The question of charge for water where more than one user is served from one meter was discussed. The Council decided that the policy should be that unless the meter was shut off, there shall be a minimum charge for each user served therefrom.

Chief of Police Delp reported several cigarette vending machines in operation in town and that he was getting complaints about children obtaining cigarettes through them. It was moved by Shook and seconded by Klein that an ordinance be drawn banning cigarette vending machines from Milwaukee. Motion carried and so ordered.

Manager Sperr requested the Council to go on record as being in favor of requesting the State Highway Department to put a protective fence along the Lake Shore bordering on McLoughlin Blvd. and along Johnson Creek north of the River Road junction where the same borders on McLoughlin Blvd. The Council agreed that this request be granted.

A letter from the State Highway Department, under date of August 24, signed by W. C. Williams, was read. The letter outlined a proposal whereby traffic could be controlled at the intersection of River Road and Scott Street, with McLoughlin Blvd. The letter stated that traffic signals at this point would cost approximately \$3,202.00 of which the City would be expected to pay one half, and that all electrical energy for the operation of the signals would be chargeable to the City. The Council took no action on this proposal at

this time.

Mr. Floyd Taylor came before the Council and requested to place an oil and gasoline distribution plant on Lots 8-9-10 Block 2 Leo Addition. Mr. Taylor also offered to give ten feet off the south of this property for widening of Llewellyn Street. Manager Sperr reported to the Council that the Planning Commission had approved Mr. Taylor's proposal, subject to a decision of the attorney as to the propriety of the useage of Industrial zoned property for the retail sales station proposed to be placed on the property along with the wholesale plant. Attorney Kirkpatrick gave his decision as follows: In as much as the property would be used primarily for wholesale distribution and that the retail sales department would be in conjunction with the wholesale operation, that it would be permitted to operate. It was moved by Clay and seconded by Shook that Mr. Floyd Taylor be permitted to place an oil and gasoline distribution business on Lots 8-9-10, Block 2 Leo Addition, and that the City accept ten feet off the south side of said lots to be used for street purposes. Motion carried and so ordered.

Ordinance Number 588 was taken up and read for its first reading. It was moved by Klein and seconded by Clay that Ordinance No. 588 be passed to its second reading. Motion carried and so ordered.

It was moved by Klein and seconded by Shook that the City Recorder be authorized to advertise bicycles presentlu on hand in the Police Department and that she be authorized to sell at auction, any bicycle unclaimed. Motion carried and so ordered.

It was moved by Klein and seconded by Shook that the following bills be approved and that warrant-checks be drawn for the payment of same after their approval by the City Manager.
