TOWN HALL, MILWAUKIE, OREGON, OCTOBER 13TH, 1914.

The one hundred fifty-first (151) regular meeting of the Town Council of the Town of Milwaukie was held on the above named date. Meeting called to order by Mayor Elmer. Present, Mayor Elmer, councilmen Mitchell, Loeding, King, Counsell and Albee, Recorder Mathews and Marshal Reed. The minutes of the one hundred fiftieth (150) regular meeting of the Council held on the 8th day of September, 1914, were read and approved as read. The following bills were read and allowed by the Finance Committee and upon motion of councilman Mitchell seconded by councilman Loeding and carried, the recorder was instructed to draw warrants on the several funds in payment of the same:

Upon motion duly made and carried, the Recorder was instructed to notify the S. P. Co. to repair its railroad crossing in Milwaukie by planking the same. A petition for the installation of an arc light on Milwaukie and Sandy Road was read and referred to Street Committee.

A petition to change the name of Front Street to Milwaukie Highway was read and referred to Street Committee. A petition to establish the grades of the Streets in Sellwood Addition was read and upon motion duly made and carried, the petition was allowed and the engineer instructed to establish the grades as petitioned for.

Upon motion of councilman Mitchell seconded by councilman King and carried, L. H. Campbell was granted until April 1st, 1915, to begin the construction of a railroad in Milwaukie.

Upon motion duly made and carried, Ordinance No. 116 was taken up for the first reading. The ordinance being read, the roll-call showed the following results: Ayes, Mitchell, Loeding, King, Counsell and Albee Nays, none. Ordinance No. 116 passed the first reading.

Upon motion of councilman Albee seconded by councilman Loeding and carried, the rules were suspended and ordinance No. 116 was taken up for the second reading and read by title only. The roll-call showed the following results: Ayes, Mitchell, Loeding, King, Counsell and Albee. Nays, none. Ordinance No. 116 passed the second reading.

Upon motion of councilman Mitchell seconded by councilman Counsell and carried, the rules were suspended and ordinance No. 116 was taken up for the third and final reading and read by title only. The roll-call showed the following results: Ayes, Mitchell, Loeding, King, Counsell and Albee. Nays, none. Ordinance No. 116 passed the third and final reading. Upon motion of councilman Loeding seconded by councilman Mitchell and carried, the recorder was instructed to advertise for bids for the Front and Dewitt Streets improvement bonds, said bids to be opened on the 20th day of October, 1914.

The matter of allowing the High School students to play basket ball in the City Hall was referred to the Fire Commission for recommendation.

Upon motion duly made and carried, the Fire Commission was authorized to purchase a stove and other necessary fixture for the East Milwaukie Fire House and to install a fire alarm system.

The Treasurer's report was read and order placed on file.

The election Committee reported that they had selected the following persons to act as judges and clerks of the Primary election to be held on the 2nd day of November, 1914: Ward No. 1; W. A. Hanson; Chas. Mullan; Dan Mazzie, Judges; Arthur Webster and Adam Keck, Clerks. Ward No. 2. Judges, S. Hayes; J. James; Jas. Philips. Clerks; L. H. Campbell and Len Warren. Upon motion duly made and carried, the report of the Election Committee was adopted and the above named persons were appointed judges and clerks of the said election. The Street Committee reported that the improvement of Harrison Street had been completed in accordance with the specifications and contract and that they would recommend the acceptance of the same. Upon motion duly made and carried, the report of the Street Committee was adopted. Upon motion of councilman Mitchell seconded by councilman Loeding and carried, the improvement of Harrison Street was accepted. Upon motion duly made and carried, the Council adjourned until the 20th day of October, 1914.

TOWN HALL, MILWAUKIE, OREGON, OCTOBER 20TH. 1914.

An adjourned meeting of the one hundred fifty first (151) regular meeting of the Town Council was held on the above named date. Meeting called to order by presiding councilman Mitchell. Present, councilman Mitchell, Loeding, Counsell and Albee, Recorder Mathews, and Marshal Reed. Upon motion duly made and carried, the bids for the Front Street improvement bonds were opened and read, and upon motion duly made and carried, the bid of Montague-O'Reilly Company for \$27,474.72, (the same being paid and accrued interest was accepted and the bonds awarded to said Company. Upon motion duly made and carried, the opening of the bids for the Dewitt Street improvement bonds was postponed until the next meeting. The proposed assessment for the improvement of Harrison Street was read, and upon motion duly made and carried, the 10th day of November, 1914, was the time set for hearing objections thereto. A bill from the Minthorn Springs Water Company for connecting up fire hydrants was read and referred to the Finance Committee. The bill of W. F. Kelso for \$12.00 for registering voter was read, and the recorder was instructed to draw a warrant ~~in~~ in payment of the same. An invitation from the Milwaukie Volunteer Fire Department to attend the Grand Opening of the new fire station was read and the Recorder was instructed to notify the fire department of the Council acceptance of the same.

The application of F. L. Kellogg for a pool room license was read and referred to the license committee, whereupon the license Committee recommended that Mr. Kellogg be granted a license. upon motion duly made and carried, the report of the committee was adopted and the recorder was instructed to issue a license to F. L. Kellogg. The following report of the Fire Committee was read and adopted as read: Milwaukie, Oregon, Oct. 20th. 1914. Mr. Mayor: The chief of the Fire department and the Fire Commission to whom you referred the matter of using the City Hall for Basket Ball recommends that the request be not granted on the account of the damage that would result to the hall from such use.
