

said plans and specifications and estimates are satisfactory to the Council of the Town of Milwaukie:

THEREFORE BE IT RESOLVED that said plans, specifications and estimates be and the same are hereby adopted and approved, AND BE IT FURTHER RESOLVED that it is the purpose and intention of the Town of Milwaukie by its Town Council to make said improvements, being described as follows, to-wit:

1. By grading the street to a grade to be adopted, which grade shall be on a level with lower bead on hydrant, said hydrant being 380 feet distant south of Washington Street.
 2. By properly rolling and settling said street.
 3. By putting in a 4" tile drain all along the East side of said Street.
 4. By macadamizing said street with 10" of gravel or crushed rock for a width of 18' when same has been properly rolled and settled. The final coating to be fine material rolled on said street.
 5. By constructing a small retaining wall next to the Hager Creek 20 feet or so long and to a height sufficient to prevent earth slipping into creek below dam.
 6. The distance across ravine from Washington Street walk to grade on the south to be spanned with a light trestle and side walk to be laid on the same with a substantial railing on the east side, all to be of wood.
 7. By constructing concrete side walks 5 feet in width on both sides of said street from end to end, save and except the wood walks above mentioned.
 8. By properly parking and ditching said street. No curbs to be installed. All to be done in accordance with the plans and specifications heretofore filed with the Recorder of the Town of Milwaukie and approved by this resolution.
- The Town Recorder is hereby directed to cause this resolution and notice to be posted as required by the Charter of the Town of Milwaukie, Oregon.

Upon motion duly made and carried, the Recorder was instructed to prepare an ordinance providing for the improvement of 27th Street, and post a copy of the same as required by the City Charter. TOWN HALL MILWAUKIE, OREGON, OCTOBER 19, 1916.

An adjourned meeting of the one hundred seventy-fifth regular meeting of the council of the Town of Milwaukie was held on the above named date. Meeting called to order by Mayor Pelton. Present, Mayor Pelton, councilmen, Snyder, Gracie, Miller, Shindler and Counsell, Recorder Mathews, Treasurer Streib, and Marshal Riley.

Mr. Carver was present and promised the Council that he would provide a spark arrester for his engine to prevent fires and would install two railroad crossing signs where his train crosses the two principal streets. Upon motion duly made and carried, the matter of straightening the street at Mr. Toates' place was dropped for the present. Upon motion duly made and carried, Ordinance No. 147, entitled, "An ordinance providing for the improvement of 27th Street in the Town of Milwaukie, Oregon, from the south line of Washington Street to a point about 1000 feet south of the south line of Washington Street, and declaring an emergency", was taken up for the first reading. The ordinance being read the roll-call showed the following result: Ayes, Gracie, Snyder, Miller, Shindler and Counsell. Nays, none. Ordinance No. 147 passed the first reading. Upon motion of councilman Counsell seconded by councilman Snyder and carried, the rules were suspended and Ordinance No. 147 was taken up for the second reading and

read by title only. The roll call showed the following result: Ayes, Grastle, Shinder, Snyder, Miller and Counsell. Nays, none. Ordinance No. 147 passed the second reading. Upon motion of councilman Miller seconded by councilman Shindler and carried, the rules were suspended and ordinance No. 147 was taken up for the third and final reading and read by title only. The roll call showed the following result: Ayes, Grastle, Snyder, Miller Shindler and Counsell. Nays, none. Ordinance No. 147 passed. Upon motion duly made and carried, the Recorder was instructed to advertise for bids for a period of five days in The Daily Record-Abstract for the improvement of 27th. street in accordance with the plans and specifications. Upon motion duly made and carried, the Recorder was instructed to enter into a contract, on behalf of the Town, with the Portland, Railway Light & Power Co, to furnish electric power for the Water Dept. Moved and seconded that the School District be notified to move the school desks from the City Hall. Motion carried. The report of the Treasurer was read and ordered placed on file. Upon motion duly made and carried, the Recorder was instructed to advertise for bids for the sale of the old water tank and tower on Shindler Street.
