MEETING OF NOVEMBER 14, 1949

COUNCIL CHAMBERS

736th MEETING

The three hundred seventy-sixth regular meeting of the Council was held on the fourteenth day of November, 1949.

The meeting was called to order by Mayor Sperr.

Present: Mayor Sperr; Councilmen Taylor, Mortensen, Frady, and Norbeck, Manager Taber, Attorney Kirkpatrick, and Recorder Martin.

The minutes of the seven hundred thirty-fifth regular meeting of the Council, held on the twenty-fourth day of October, 1949, were approved as written.

Mr. W.T. Rasmussen laid before the Council plans for a duplex house and asked for a permit to build the same on 37th Street between Harrison and Monroe Streets. It was moved by Mortensen and seconded by Taylor that the Mayor appoint a viewing committee, with power to act, in the matter of approving a permit for a two family dwelling in a 3 R 1 zone at 37th Street between Harrison and Monroe Streets. Motion carried and so ordered. Mayor appointed all members of the Council to act on this committee.

One of the tenants at the apartment house at 2325 Harrison Street came before the Council and made complaint that although the price of rent included heat, they were not being served with adequate heat, and at times there was no heat at all. It was moved by Sperr and seconded by Norbeck that the Manager make investigation as to how apartment heating is controlled in other cities near Milwaukie. Motion carried and so ordered.

Mr. J. Kyle came before the Council and requested that the Council make application for decontrol of rent in Milwaukie. Mr. Kyle was advised that the proper approach to the Council on this matter was by petition of the landlord in Milwaukie, which Mr. Kyle volunteered to provide.

Mr. Glen Cottrell came before the Council and complained of a public nuisance at 31st Street in Quincy Addition. The Mayor appointed the following committee to investigate the Leo Fontana property on 31st Street, Quincy Addition, and the Hager property at 2736 Washington Street. Manager Taber, Officer Delp, Fire Chief Lewellyn, and Councilman Frady.

Councilman Frady brought up the question of pay increases for the Police and Firemen. It was moved by Taylor and seconded by Norbeck that the matter of salary raises be investigated by Manager Taber and that his findings together with the financial status of the budget be reported at the next meeting of the Council. Motion carried and so ordered.

It was moved by Taylor and seconded by Frady that the City office be closed on election day November 15. Motion carried and so ordered.

It was moved by Mortensen and seconded by Frady that the Council grant a recommendation for a renewal of a Retail Malt Beverage Class A license for Mr. Owens Pit, Washington Street at Front Street. Motion carried over one disending vote and was so ordered.

It was moved by Taylor and seconded by Norbeck that the following
