




PROCLAMATION BY THE MAYOR OF THE
CITY OF MILWAUKIE, OREGON

I, ROBERT E. RICHMOND, MAYOR of the City of Milwaukie, Clackamas County, Oregon, do hereby proclaim and declare that the question of establishing a new tax base for the City of Milwaukie, submitted to the legal voters of said City for their adoption or rejection at a regular election held at the same time as the State General Election on the 8th of November, 1966, appearing on the official ballot and designated by the following ballot title, to-wit:

No. 735 of the City of Milwaukie, Oregon, do hereby proclaim, make known and declare that 3197 votes were cast in favor of the above measure and that 2020 votes were cast against said measure and that the vote on the said measure at the regular City election shows a majority who voted on it to be in favor of it.



A RESOLUTION PROVIDING FOR THE CITY OF MILWAUKIE, OREGON, TO ENTER INTO AN AGREEMENT WITH THE STATE OF OREGON FOR THE INSTALLATION OF SAFETY SIGNALS AT 21st AND LAKE ROAD.

WHEREAS, the City Council of the City of Milwaukie, Oregon, has determined that safety improvements must be made at the intersection of Lake Road and 21st Street, in order to obtain a safer and more expeditious flow of traffic, and


WHEREAS, the State of Oregon by and through its State Highway Dept., has agreed to prepare all plans, let and award all contracts and supervise the installation of the traffic signals, at an estimated total cost of \$1,600, with the City of Milwaukie participating in the cost of installation to one-half the actual cost, and

WHEREAS, the City of Milwaukie has deemed it to be in the best interests of the inhabitants of the City for their safety and welfare,


NOW, THEREFORE, BE IT RESOLVED, that the City of Milwaukie enter into an agreement with the State of Oregon, by and through its State Highway Department for the installation of safety signals at the intersection of Lake Rd. and 21st Street, and that the financial cost be shared equally by the State of Oregon and the City of Milwaukie.

BE IT FURTHER RESOLVED, that the City shall, at its own expense, after completion of the project, maintain the traffic signals and pay for all electrical energy consumed by the same.
