

TOWN HALL MILWAUKIE, OREGON, NOV. 16TH, 1914.

An adjourned meeting of the one hundred fifty-second (152) regular meeting of the Town Council was held on the above named date. Meeting called to order by Mayor Elmer. Present, Mayor Elmer, Councilmen, Mitchell, Loeding, King, Counsell and Albee and Marshal. Recorder Mathews being absent, W. F. Kelso was appointed Recorder pro. tem. The report of the Street Committee on ordinance No. 114 was read and adopted as read.. Ordinance No. 114 was read and ordered posted.

Upon motion duly made and carried, ordinance No. 118 was taken up for the first reading. The ordinance being read the roll call showed the following results: Ayes, Mitchell, Loeding, King Counsell and Albee. Nays, none. Ordinance No. 118 passed the first reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 118 was taken up for the second reading and read by title only. The roll call showed the following results: Ayes, Mitchell, Loeding, King, Counsell and Albee. Nays, none. Ordinance No. 118 passed the second reading. Upon motion of Councilman Albee seconded by councilman Loeding and carried, the rules were suspended and ordinance No. 118 was taken up for the final reading and read by title only. The roll call showed the following results: Ayes, Mitchell, Loeding, King, Counsell and Albee. Nays, none. Ordinance No. 118 passed.. The petition of Fennie Minsburg for a liquor license ~~xxxxxx~~ to sell ~~xxxxxx~~ spiritous, vinous and malt liquors in the building know as the Hotel Belle, was read and referred to the License Committee. The License Committee recommended that the License be granted on the condition that no women or drunken men be allowed in any room in said Hotel in which liquors are ~~sax~~ served. Violation of this condition ~~is~~ will work a forfeiture of this license. Upon motion duly made and carried, the report of the Committee was adopted and the license granted. Mitchell, Loeding Counsell and Albee voting yes and King voting no.

Upon motion duly made and carried, the Engineer was instructed to assess the cost of the bridge on Monroe Street to the Town of Milwaukie. The resignation of Mayor Elmer was read and referred to the Council as a Committee of the whole. Upon motion duly made and carried, the Council adjourned until the 28th of Nov. 1914.

An adjourned meeting of the one hundred fifty-second regular meeting was held on the above named date. Meeting called to order by presiding councilman Mitchell. Present, councilmen, Mitchell, Loeding, Albee and Counsell, Recorder Mathews and Marshal Reed.

The Street Committee reported that Monroe Street had been completed according to the plans and specifications and was ready for acceptance. Upon motion duly made and carried, the improvement of Monroe Street was accepted. The proposed assessment for the improvement of Monroe Street was read, and upon motion duly made and carried, the 15th day of December, 1914, was the time set for hearing objections to the said assessment.

A communication from the Lumbermens Trust Company calling for the delivery of the Water Bonds was read, and upon motion duly made and carried, the Mayor and Recorder was instructed to execute said bonds and delivered them to the Lumbermens Trust Company, and as the said Company agreed to pay 3% interest on the daily balances, to deposit the purchase price of said bonds in the Lumbermens National Bank. Upon motion duly made and carried, Ordinance No. 119 entitled, "An ordinance declaring the assessment for the improvement of Harrison Street in the Town of Milwaukie, Oregon, and declaring an emergency," was taken up for the first reading, the ordinance being read the roll call showed the following results: Ayes, Loeding, Counsell and Albee. Nays, None. Ordinance No. 119 passed the first reading. Upon motion duly made and carried, the rules were suspended and ordinance No. 119 was taken up for the second reading and read by title only. The roll call showed the following results: Ayes, Loeding, Counsell and Albee. Nays, none. Ordinance No. 119 passed the second reading.

Upon motion duly made and carried, the rules were suspended and ordinance No. 119 was taken up for the third and final reading and read by title only. The roll call showed the following Results: Ayes, Loeding, Counsell and Albee. Nays, None. Ordinance No. 119 passed the third and final reading. A petition of some of the property owners on Washington Street for the instillation of an Arc Light to be installed at Scharner Corner on Washington Street was read and referred to the Light Committee. Upon motion duly made and carried, the Treasurer was instructed to transfer \$800.00 from the general fund to the Front Street fund in order to pay the interest of the Front Street bonds. Upon motion duly made and carried, the Council adjourned until the 3rd day of December, 1914,
