

TOWN HALL MILWAUKIE, OREGON, DECEMBER 13TH, 1912.

A special meeting of the Town Council of the town of Milwaukie was held on the above named date. Meeting called to order by Mayor Streib. Present, Mayor Streib, Councilmen Knight, Kelso and Stockton and Recorder Mathews.

Mayor Streib stated that the meeting was called for the purpose of considering the bill of W. H. Counsell for laying walks on Oak and Fourth streets and for the acceptance of the improvement of Monroe Street and the Milwaukie and Sandy Road. A letter from D. W. Campbell of the Southern Pacific Company, containing a duplicate of the requisition for the steel overhead crossing for Foster Road, was read and ordered filed. Upon motion of Councilman Knight seconded by Councilman Stockton and carried, the bill of C. Kerr for interest on warrant to the amount of \$40.00 was allowed and the Recorder instructed to draw a warrant on the general fund for the same. Upon motion of Councilman Knight seconded by Councilman Kelso and carried, the improvement of Monroe street and Milwaukie and Sandy Road was accepted. Upon motion of Councilman Knight seconded by Councilman Kelso and carried, the Recorder was instructed to draw two warrants on the Monroe Street fund, one for \$71.48 and one for \$896.95, in favor of W. H. Counsell, payment in full for the improvement of Monroe Street, and also two warrants on the Milwaukie and Sandy Road fund, one for \$520.83 and one for \$657.03, in favor of W. H. Counsell payment in full for the improvement of Milwaukie and Sandy Road.

No further business coming before the Council moved and seconded that the Council adjourn. Carried.

TOWN HALL MILWAUKIE, OREGON, JANUARY 6TH., 1913.

A special meeting of the Town Council of the Town of Milwaukie was held on the above named date. Meeting called to order by Mayor Elmer. Present, Mayor Elmer, Councilmen Counsell, Mitchell, King and Davis, Recorder Mathews and Marshal Davis.

Mayor Elmer stated that the meeting was called for the purpose of considering the proposition made by J. E. Wetzler to purchase the tract of land lying between Front and Main Streets on the north side of Washington Street. Upon motion of Councilman King seconded by Councilman Mitchell and Carried, the Recorder was instructed to post notices of sale of the said property. Upon motion of Councilman Mitchell seconded by Councilman King and carried, the recorder was instructed to consult R. R. Giltner for legal advice as to the kind of deed to make the purchaser of the said property, which would fully protect the town.

Mayor Elmer appointed the following committees, to-wit:

 Street and Public Property Committee: Patrick King, C. H. Counsell and F. R. Mitchell.
 Light, Health and Water Committee: C. H. Counsell, F. R. Mitchell and A. C. Davis.
 Police, License and Fire Committee: A. C. Davis, C. H. Counsell and Patrick King.

No further business coming before the Council moved and seconded that the Council adjourn. Carried.

TOWN HALL, MILWAUKIE, OREGON, JANUARY, 14TH. 1913.

The one hundred thirtieth (130) regular meeting of the Town Council of the Town of Milwaukie was held on the above named date.

The meeting was called to order by Mayor Elmer. Present, Mayor Elmer, councilmen Davis, Mitchell, King and Counsell, Recorder Mathews and Marshall C. B. Davis.

Mayor Elmer outlined his policy to the Council and made the following recommendations:

1. More adequate supply of pure water for both domestic and fire purposes.
2. The organization of a Volunteer Fire Department.
3. Street improvements consistent with good business judgment.
4. The settlement of the difficulties that are now obstructing the completion of certain Streets.
5. The night policing of the Town to prevent noise and rowdyism on the Streets.
6. To see that the saloon conform to the law under which they are licensed.
7. The division of the Town into two or more wards.
8. The passage of an ordinance calling for a special election to vote upon the proposed amendments to the Charter.

The minutes of the one hundred twenty-ninth (129) regular meeting held on the 10th. day of December, 1912, also the minutes of the special meetings held on the 13th. day of December, 1912, and on the 6th day of January, 1913, were read, and upon motion of councilman Counsell seconded by councilman King, and carried, the minutes were approved as read.

The bills were read, and upon motion of Councilman Mitchell seconded by councilman Davis, and carried, the bill of W. H. Counsell for putting in wood cross walks on Fourth and Oak streets was referred to the street Committee and the remainder to the finance Committee.
