

Town Hall, Milwaukie, Oregon, Jan. 21st. 1919.

A special meeting of the Council of the Town of Milwaukie, Oregon, was held on the above named date. Meeting called to order by Mayor Snyder. Present, Mayor Snyder, councilmen, Grasle, Frutchey, Miller, Counsell and Hart, Recorder Mathews and Marshal Riley. The opinion of Gilbert-L. Hedges construing section 14 of the Town Charter was read and ordered placed on file. Upon motion duly made and carried, the qualification of ~~EM~~ J. W. Hart and C. H. Counsell, the newly elected councilmen, was accepted. The Mayor appointed the following Committees for the year 1919; Finance, J. W. Frutchey, W. H. Grasle and J. J. Miller; Street & Water, C. H. Counsell, J. W. Hart and J. J. Miller; Light, J. J. Miller, J. W. Frutchey and W. H. Grasle; License, J. W. Hart, C. H. Counsell and J. J. Miller; Police and Health, W. H. Grasle, C. H. Counsell and J. J. Miller; Fire, C. H. Counsell and J. W. Hart. Upon motion duly made and carried, the Street Committee was instructed to take up the matter of repairing the street in front of Mr. Philip Streib's property and of the other streets that need repairing. Upon motion duly made and carried, the recorder was instructed to notify the Portland Gas & Coke Company to immediately repair the streets that they had dug up to lay their gas mains. Upon motion duly made and carried, the appointment of Dr. Lowe as City Health officer was confirmed. Upon motion duly made and carried, the Water Supt. was instructed to immediately install a meter on the Reid water pipe ~~ix~~ at the house where the Jap. is living. Upon motion duly made and carried, the Council adjourned.

Town Hall Milwaukie, Oregon, February 4th. 1919.

The two hundred third regular meeting of the Council was held on the 4th day of February, 1919. Meeting called to order by Mayor Snyder. Present, Mayor Snyder, councilmen, Grasle, Frutchey, Miller, Hart and Counsell, recorder Mathews, Marshal Riley and Treasurer Streib.

The minutes of the two hundred second regular meeting of the Council held on the 7th day of January, 1919, and the minutes of the special meeting held on the 21st day of January, 1919, were read and approved as read. The Street Committee reported that they ~~had~~ were unable to secure any help and had done very little to ward repairing the streets. Upon motion of councilman Miller duly seconded and carried, the Water Supt. was instructed to purchase one dozen globe valves for fire hydrants and the necessary hose connections to fit the same.

Upon motion duly made and carried, the Recorder was instructed to draw a warrant in favor of J. H. Gibson, Receiver of the Minthorn Springs Water Company, for \$122.85 in payment for the water pipe purchased from the Company. A communication from the Portland Gas and Coke Company in regard to repairing the streets which they dug up in order to lay gas mains was read and ordered placed on file. A communication from the P. R. L. & P. Company in regard to repairing the Arc Lights in the Town was read and ordered placed on file. A communication from the S. P. Co. in regard to installing a drain under it track on Harrison Street was also read and ordered placed on file. Upon motion duly made and carried, the Marshal was instructed to notify Mr. Hager to remove his ~~front~~ ^{front} off the sidewalk.

The following bills were read and allowed by the Finance Committee and upon motion duly made and carried, the Recorder was instructed to draw warrants in payment of the same:
