

TOWN HALL, MILWAUKIE, OREGON, MARCH 25TH. 1921.

A special meeting of the Council of Milwaukie was held on the above named date. Meeting called to order by Mayor Snyder. Present, Mayor, Snyder, councilmen, Miller, Albee, Shindler and Counsell, Recorder Mathews, Treasurer Streib and Marshal Reed. Councilman Counsell informed the Council that the City hall was in a dangerous condition and that it was unsafe for the school children to be using the same.

Upon motion duly made and carried, the Recorder was instructed to notify the School Clerk that the City Hall was in a dangerous condition and that it was unsafe for the School children to be using the same, and if they continued to use the same it would be at their own risk.

The matter of securing an additional attorney to aid in the rehearing of the case of Montague & O'Reilly Co. vs. Town of Milwaukie was discussed and the Recorder was instructed to take the matter up with Mr. Meacham and get his opinion on the matter.

Upon motion duly made and carried, the Council adjourned.

TOWN HALL, MILWAUKIE, OREGON, APRIL 5TH. 1921.

The two hundred twenty-ninth regular meeting of the Council of the Town of Milwaukie was held on the 5th day of April, 1921. Meeting called to order by Mayor Snyder. Present Mayor Snyder, councilmen, Miller, Hart, Counsell and Shindler, Recorder Mathews, Treasurer Streib and Marshal Reed. The minutes of the two hundred twenty-eight regular meeting of the council held on the 9th day of March, 1921, and the minutes of the special meeting of the council held on the 25th day of March, 1921, were read and approved as read. The application of C. F. Witte for a dance Hall license was taken up for consideration, and upon motion duly made and carried, the application was granted and the Recorder was instructed to issue a dance Hall license to Mr. Witte.

Mr. Hopkins was present and asked the Council to re-advertise for bids for the improvement of 32nd, Street. Upon motion duly made and carried the Recorder was instructed to re-advertise for bids for the improvement of 32nd street in the Daily-Record Abstract, said bids to be opened the 20th day of April, 1921, at 8:00 o'clock P. M. of said day. Mr. Sellwood was present and asked what the Council would do toward helping the property owners on 30th Street fix said street.

The council informed Mr. Sellwood that the Town would contribute an amount equal to the amount raised by the property owners along said Street, and as soon as the property owners paid in the amount so raised to the City Treasurer the Town would turn over a like amount to the Treasurer, said funds to be used for the purpose of fixing and repairing 30th. Street. Said Street to be fixed and repaired under the supervision of the Street Committee of the Town of Milwaukie.

The following bills were read and allowed by the Finance Committee and upon motion duly made and carried, the Recorder was instructed to draw warrants in payment of the same:
