

TOWN HALL MILWAUKIE, OREGON, APRIL 15TH. 1915.

A special meeting of the Town Council of the Town of Milwaukie was held on the above named date. Meeting called to order by Mayor Pelton. Present, Mayor Pelton, Councilmen, Pond, Peery, Grasle, Skulason and Counsell, Recorder Mathews and Marshal Riley. The mayor stated that the meeting was called for the purpose of considering the calling of a special election to vote on the proposed amendment to the City Charter.

Moved by councilman Skulason and seconded by councilman Grasle that a special election be held on the 1st day of May, 1915, to vote upon the following proposed amendments to the City Charter: " A Bill for an act to amend the charter of the Town of Milwaukie, in the County of Clackamas, in the State of Oregon, by adding thereto the following, which shall be designated therein and may be cited as " Sections 1, 2, 3 and 4 of the 1915 Water Works Condemnation and Purchase Amendment," providing for and authorizing and instructing the Mayor and Council to acquire for Milwaukie, by purchase at voluntary sale or by condemnation or arbitration, all the waterworks, systems, rights and all other property of the Milwaukie Water Company, and of the Minthorne Springs Water Company, to make payment therefor, and to repeal all provisions of the Charter and ordinance of Milwaukie in conflict herewith." Also, A Bill for an act to amend the City Charter of Milwaukie, in the County of Clackamas and State of Oregon, by adding thereto the following section, which shall be designated therein and may be cited as "The Minthorne Springs and Pull Run Water Advice Amendment of 1915," and to provide for a vote by the people of Milwaukie to advise the Mayor and Council of Milwaukie as to whether the people favor buying Minthorne Springs as a water supply for said Town, or prefer buying Pull Run water from Portland at a fixed price per gallon." Motion carried. Upon motion duly made and carried, Council adjourned.

The Mayor Stated that the meeting was called for the purpose of canvassing the votes cast at the special election held on the first day of May 1915.
