Present Mayor Miller, Councilmen Dean, Dell, Shrock and Walsh; Marshal Keck and Recorder Adams.

The recorder presented the applications of D. C. Talcott, Hilda Carlson Vera Milan, and Paul Sosey and recommended that the applications be approved.

Upon motion duly made and carried it was ordered that the application of Vera Milan be approved and that she be licensed to sell non-intoxicating beverages on the premises known as the Milwaukie Pool Room.

Upon motion duly made and carried it was ordered that the application of Paul Sosey be approved and that he be licensed to sell non-intoxicating beverages in the original package on the premises known as Sosey's Pharmacy.

Upon motion duly made and carried it was ordered that all other applications be laid on the table until the applicants could appear personally.

Upon motion duly made and carried it was ordered that C. O. Wilson be released as relief agent.

Upon motion duly made and carried it was ordered that Richard Rivers be appointed relief agent effective as of April 17, 1933.

A special meeting of the Council of the Town of Milwaukie was held on the 25th day of April, 1933, pursuant to the call of Mayor Miller, for the purpose of receiving and acting upon the report of the Committee appointed by the Mayor to study and negotiate a franchise granting unto the Portland General Electric Company the right to do business within the Town of Milwaukie and to consider other matters up for the Council's attention. Present, Mayor Miller, Councilmen Dell, Shrock and Walsh, Marshall Keck and Recorder Adams.

The franchise committee through its chairman, E. B. Stanley, submitted a proposed franchise to the Council and recommended that the same be ordered posted without delay. Mr. Stanley also submitted a letter signed by all members of the committee in which the council was urged to adopt the proposed franchise ordinance without change.

The recorder read the proposed franchise ordinance section by section
