

SPECIAL MEETING OF APRIL 23, 1962

A special meeting of the Council of Milwaukie was held on the twenty-third day of April, for the purpose of a hearing on the withdrawal of recently annexed territories from the Milwaukie Rural Fire Protection District and the Wichita Zoning District, and such other business necessary to come before the Council at this time.

The meeting was called to order by Mayor Earl M. Clay.

The rollecall showed the following result. Present: Mayor Earl M. Clay; Councilmen James Howard, Charles Renard, E. H. Aebi and Theron Sedgwick; City Manager Leonard Mullan, City Attorney John O. Sheldahl and Clerk Ellen Martin.

A request for recommendation for Package Store Class B liquor license for Dean's Thriftway Store, 846 32nd Street, (formerly Lew's Market) was laid before the Council by Alvin Dean Smith and Oneita Wood Smith. A letter of recommendation, signed by Chief of Police Brittingham, accompanied the application. It was moved by Sedgwick and seconded by Aebi that the recommendation be granted. Motion carried and so ordered.

Manager Mullan reported that Mr. Fossatti, owner of a building at 1227 Main Street had offered to improve his building by re-wiring and re-plumbing and a general clean-up. After discussion, the COUNCIL advised the Manager that inasmuch as the building is old and a fire hazard, they could not approve it structurally although the wiring and plumbing would be new. Along with this discussion there was discussion with regard to the Ledding estate property, particularly the buildings on Lots 2,3,4, Block 15 Milwaukie. It was moved by Sedgwick and seconded by Howard that the City Attorney write a letter to the executors of the Ledding Estate, stating that the City Council is anticipating condemnation of these buildings for occupancy. Motion carried and so ordered.

The time having arrived, the Mayor opened the hearing on the withdrawal from the Milwaukie Rural Fire Protection District, properties recently annexed to the city by ordinances No.s 889, 893, 894 and 895 and called for objection to the same. There was no person present who objected and no written objection had been received. The Mayor declared the hearing closed.

Ordinance No. 902 was taken up and read for its first reading. It was moved by Sedgwick and seconded by Howard that Ordinance No. 902 be moved to its second reading and that it be read at this time. Motion carried and so ordered.

There was no person present who made objection and no written objection had been received. The Mayor declared the hearing closed.

Ordinance No. 903 was taken up and read for its first reading. It was moved by Howard and seconded by Sedgwick that Ordinance No. 903 be passed to its second reading and that it be read at this time. Motion carried and so ordered.
