

SPECIAL MEETING OF JUNE 23, 1953

A special meeting of the Council was held on the twenty-third day of June, 1953

The meeting was called to order by Mayor Mullan.

Present: Mayor Mullan, Councilmen Shook, Clay, Klein and Wright, Manager Sperr and Attorney Kirkpatrick. Absent: Recorder Martin.

It was moved by Klein and seconded by Shook that in as much as the Board of Directors of Union High School District No. 5 of Clackamas County, Oregon has requested an expression from the City Council regarding the extension of the proposed High School gymnasium addition to an area within ten feet of 23rd Street property line and has in effect withdrawn its request for permission on the matter, it is moved that the City Council express itself that we, (1) do not favor the placing of such public building with the main entrance on the 23rd Street bottleneck, (2) suggest a re-planning of the structure with a view to gaining a more suitable location and entrance, (3) to this end suggest working with the City Planning Commission who is well informed of the problems of the area and can offer constructive help, and (4) are not in favor of the six foot set back which we feel is only a minor, but nevertheless key consideration in the overall unsatisfactory plan. Motion carried and so ordered.

SPECIAL MEETING OF JUNE 29, 1953

A special meeting of the Council was held on the twenty-ninth day of June, 1953.

The meeting was called to order by Mayor Mullan.

Present: Mayor Mullan, Councilmen Shook Clay, Klein and Wright, Manager Sperr and Attorney Kirkpatrick. Absent: Recorder Martin.

Discussion of budget held pursuant to published notice.

Library Board protested cut in its budget for the year 1953-54.

It was moved by Shook and seconded by Wright that the budget stand as approved by the budget committee. Motion carried and so ordered.

Ordinance Number 586 was read for the first time. It was moved by Klein and seconded by Wright that Ordinance No. 586 be read the second time by title only and placed on final passage; Motion carried and so ordered. Ordinance No. 586 was read the second time by title only; and was moved by Wright, seconded by Klein that Ordinance No. 586 do pass. Roll was called with the following results: Ayes: Mullan, Shook, Clay, Klein and Wright. Nays: None. Ordinance No. 586 passed the Council and was so declared by the Mayor.

It was moved by Wright and seconded by Klein that the City Manager be authorized to issue a moving permit for the three houses facing west on 23rd Street to the approved location south of Lake Road, if and when the proposed street which said buildings will face, has been dedicated in compliance with the recommendation of the Planning Commission; and provided further that the owner enter into an agreement with the City to forfeit the sum of \$1000.00 as liquidated damages, in event, that said buildings are not placed on approved foundations and completed within six months from the date of such permit. Motion carried and so ordered.

Ordinance No. 587 was read for the first time. Moved by Klein, seconded by Clay that Ordinance No. 587 be passed to its second reading. Motion carried.

On motion duly made and seconded the meeting adjourned.
