

SPECIAL MEETING OF JUNE 15, 1964

A special meeting of the Council of the City of Milwaukie, was held on the fifteenth day of June, 1964, for the purpose of reviewing ordinances coming under the codification program and such other business necessary to come before the Council at this time.

The meeting was called to order by Mayor Joseph M. Bernard, Jr.

Those present were Mayor Joseph M. Bernard, Jr.; Councilmen Walter Freeman, Charles Renard, Theron Sedgwick and Robert Richmond; City Manager Max Thompson, and Attorney John O. Sheldahl. Absent: Clerk Ellen Martin.

It was moved by Renard and seconded by Freeman that Mr. Dallas Brown be appointed as Building Official for the purpose of the Code as adopted under Ordinance No. 879. Motion carried and so ordered.

The Council discussed the matter of the proposed interseptor sewer to serve the Omark Industrial area as well as areas east and southeast of Milwaukie. It was moved by Renard and seconded by Richmond that the Engineer's Plan A. be given first preference for the Interseptor sewer to serve the eastern area of the City and that Manager Thompson take steps to expedite the eventual construction of the sewer according to this plan. Motion carried and so ordered.

Ordinance Number 1021, AN ORDINANCE for Traffic control, providing for penalties and repealing Ordinances Numbered 7, 166, 171, 188, 240, 266, 342, 359, 421, 426, 461, 467, 271, 276, 477, 510, 511, 516, 523, 530, 560, 598, 635, 762, 809 and 938X was taken up and read for its second reading and put on its passage with the following result being had: Ayes: Freeman, Renard, Sedgwick, Richmond and Bernard. Nays: None. Ordinance Number 1021 passed the Council and was so declared by the Mayor.

Ordinance Number 1023 was taken up and read for its first reading. It was moved by Renard and seconded by Sedgwick that Ordinance No. 1023 be passed to its second reading. Motion carried and so ordered.

Ordinance Number 1023 AN ORDINANCE to amend Ordinance Number 502, was again taken up and read for its second reading and put on its passage with the following result being had. Ayes: Freeman, Renard, Sedgwick Richmond, and Bernard. Nays: None. Ordinance Number 1023 passed the Council and was so declared by the Mayor.

Ordinance Number 1024 was taken up and read for its first reading. It was moved by Sedgwick and seconded by Renard that Ordinance Number 1024 be passed to its second reading. Motion carried and so ordered.

Ordinance Number 1024, AN ORDINANCE relating to alcoholic liquor: providing a penalty; and repealing Ordinance Number 340 was again taken up and read for its second reading and put on its passage with the following result being had; Ayes: Freeman, Renard, Sedgwick, Richmond and Bernard. Nays: None. Ordinance Number 1024 passed the Council and was so declared by the Mayor.

Mayor Bernard appointed Mrs. Arlie D. Brown to serve on the Library Board for a term of four years beginning July 1, 1964.

On motion duly made and carried the meeting adjourned.
