After hearing all the evidence on both sides, the following Resolution was read and upon motion of councilman Skulason seconded by councilman Counsell and unanimously carried, the resolution was adopted as read: RESOLVED, that after hearing the evidence on both sides relating to the charges perferred by Mayor Pelton against Engineer Morris, we find no evidence to sustain such charges and find nothing to reflect on either the professional integrity or ability of Mr. Morris.
