

TOWN HALL, OCTOBER 8TH, 1920.

Res 5-1920

A special meeting of the Council of the Town of Milwaukie was held on the 8th day of October, 1920. Meeting called to order by Mayor Snyder. Present, Mayor Snyder, councilmen, Albee, Miller, Hart and Counsell, Recorder Mathews and Marshal Reed. The Mayor stated that the meeting was called for the purpose of passing a resolution taking over the jurisdiction of a certain strip of County Road. Upon motion of councilman Albee the following resolution was unanimously adopted:

"WHEREAS, on the 1st day of June, 1920, at a meeting of the Council of the Town of Milwaukie, regularly called and held, a resolution was unanimously adopted, reciting that the said Council deemed it necessary and expedient and for the best interests of said Town of Milwaukie to acquire jurisdiction over a certain strip of county road lying within the corporate limits of said Town, and described as follows: The South Forty (40) feet thereof as laid originally laid out, lying between the northeast corner of the Lot Whitcomb Donation Land Claim, and a point in the North line of said Donation Land Claim distant fifteen and one-half (15 1/2) rods west from said corner of said Donation Land Claim:

And Whereas, the said town ~~was~~ by resolution requested the County ~~Board~~ of Clackamas, State of Oregon, and the County Court thereof to surrender to said town jurisdiction over the above described portion of said road.

And Whereas, pursuant to said resolution, a petition was filed by said town, addressed to said county court, embodying the said resolution, and the foregoing request;

And Whereas, thereafter such proceedings were had in said County Court; that on the 8th day of October, 1920, said County Court made and entered an order in compliance with the prayer of said petition, offering to surrender to said town jurisdiction over said portion of County Road No. 132, provided that such offer should be accepted by said town by appropriate resolution or ordinance within thirty days from the date of said order;

NOW THEREFORE BE IT RESOLVED by the council and the mayor of said Town of Milwaukie, that the aforesaid offer of the County of Clackamas to surrender jurisdiction over said portion of County Road as set forth in said order be and the same hereby is accepted, and that said Town of Milwaukie henceforth assume jurisdiction over the above described portion of County Road No. 132, for its improvement, construction and repair, and for the laying and collection of assessments therefor, and for the control thereof, and over the same to the same extent and in like manner as it has jurisdiction of and controls the public streets and alleys of said town by virtue of the provisions of its charter and the laws of the State of Oregon:

And Be It further Resolved, that the acceptance of said offer be communicated to said County of Clackamas and to the County Court thereof in compliance with the provisions of said order by filing in the office of the County Clerk of said County a certified copy of this resolution.

Upon motion duly made and carried, the Recorder was instructed to prepare a new traffic ordinance to comply with the State Law and post a copy of the same as required by the City Charter.

Upon motion duly made and carried, Mrs. Johnson was instructed to visit the homes of each voter and register those who have not already registered, and to copy the names of all voters in the Town of Milwaukie in alphabetical order in a book for each ward. Upon motion duly made and carried, the Council adjourned.
