

Meeting of October 8, 1962

Council Chamber

975th Meeting

The nine hundred seventy-fifth regular meeting of the Council of the City of Milwaukie was held on the eighth day of October, 1962.

Present: Mayor Earl Clay; Councilmen James Howard, Paul Baer and Theron Sedgwick; City Manager Leonard Mullan, Assistant Manager Max Thompson; City Attorney John O. Sheldahl and Clerk Ellen Martin. Absent: Councilman Charles Renard.

The minutes of the nine hundred seventy-fourth regular meeting of the Council, held on the tenth day of September, 1962, were approved as written.

The minutes of a Special meeting of the Council, held on the twelfth day of September, 1962, were approved as written.

Mr. Fred Weber came before the Council with regard to water supply for Cedar Crest, a subdivision now being developed by Mr. Weber, east of Linwood Road and north of Harmony Road. The property is in the City limits of Milwaukie and, so far as Mr. Weber knew, it is in the Clackamas Water District. Mr. Weber stated that he is planning to develop other properties along Railroad Avenue, west of Linwood Avenue, ~~west of Linwood Avenue~~, and would be needing water for these developments, and requested that the City furnish him with water for Cedar Crest and these proposed developments. There was discussion on the procedure to be taken. Councilman Baer suggested that the first move should be to withdraw these areas from the Clackamas Water District. It was moved by Sedgwick and seconded by Baer that the following Resolution be adopted.

Resolution Number 38-1962

WHEREAS, the City of Milwaukie, by appropriate statutory procedure, has heretofore annexed the following described tracts of real property, to-wit:

1. Beginning at a point in the center line of the Southern Pacific Company's right-of-way that intersects with the west boundary line of Beckman Road extended southerly.
2. Thence North along the west boundary of Beckman Road extended, to the southeast corner of Block 1, HOMEWOOD PARK.
3. Thence Northerly along the east boundary of HOMEWOOD PARK to the southwest corner of BRIARWOOD ADDITION.
4. Thence Easterly along the south boundary of BRIARWOOD ADDITION to the southeast corner of Lot 1, Block 1, BRIARWOOD ADDITION.

7. Thence Easterly along the south boundary line of STANLEY PARK No. 3, extended, to the east boundary line of Stanley Avenue.
8. Thence Southerly along the east boundary line of Stanley Avenue, extended, to the center line of the Southern Pacific Company's right-of-way.
9. Thence Northwesterly along the center line of the Southern Pacific Company's right-of-way to the point of beginning.

All being in the JOHN D. GARRETT D.L.C. and Tax Lots areas numbered by the Clackamas County Assessor as of October 1, 1962.

Part of the J. D. Garrett and wife D.L.C. #38, in T.1S., R.2E., of W.M., and part of the southwest quarter of Section 32, in T.1S., R.2E., W.M., and part of the north half of the northwest quarter of Section 5 in T.2S., R.2E., of W.M., described as follows:

Beginning at the northeast corner of the Joseph P. Eagon D.L.C. which is 1320.0 feet East of the northwest corner of Section 5, in T.2S., R.2E., W.M.; thence South on the east line of the said Eagon D.L.C. 190.80 feet, more or less, to the center of the Foster and Milwaukie County Road and to the true point of beginning of the tract herein described; thence from said true point of beginning run Easterly in the center of said Foster and Milwaukie County Road 1320.00 feet, more or less, to the North and South center line of Section 5, in T.2S., R.2E., of W.M.; thence North along said

center line of said Section 5, and the center line of Section 32, in T.1S., R.2E., of W.M., 1650.20 feet, more or less, to the southeast corner of a certain tract of land described in Book 152 at page 179, Deed Records of Clackamas County, Oregon; thence Westerly along the southerly line of these tracts of land conveyed by deeds in Book 152, page 179 and Book 178, page 249, of said Deed Records 2500.0 feet, more or less, to a point in the westerly right-of-way of the H. Loncoy County Road; thence Southerly along said westerly right-of-way line of the most easterly road of two roads commonly referred to as Loncoy Road, to a point of intersection with the northerly right-of-way line of the Foster and Milwaukie County Road; thence Easterly along the said northerly right-of-way line of the Foster and Milwaukie Road to the true point of beginning.


Beginning at the southeast corner of the Plat of MAPLEHURST in Section 32, T.1S., R.2E., of the W.M., thence Southerly along the 1/4 Section line that divides said Section 32 into east and west halves, a distance of 352.00 feet; thence South $88^{\circ} 31'$ West 900.0 feet, more or less, to a point that is 250.00 feet east of the southeast corner of Block 4 in the plat of FURNBERG PARK; thence Northerly 342.75 feet, more or less, to a point in the south boundary of said Maplehurst, that is 250.00 feet east of the northeast corner of Block 3, FURNBERG PARK; thence Easterly along the south boundary of said MAPLEHURST 900.00 feet, more or less, to the point of beginning.

AND WHEREAS, the above described real properties lie within the boundaries of the Clackamas Water District, a Water district in the County of Clackamas and State of Oregon, duly organized and existing under and by virtue of the laws of the State of Oregon.



RESOLUTION NUMBER 39-1962

A RESOLUTION PROVIDING FOR THE CALLING OF A SPECIAL CITY TAX BASE ELECTION IN THE CITY OF MILWAUKIE, OREGON, ON NOVEMBER 6, 1962, FOR THE PURPOSE OF SUBMITTING TO THE LEGAL VOTERS OF THE CITY OF MILWAUKIE, OREGON, THE QUESTION OF ESTABLISHING A NEW TAX BASE FOR THE PURPOSE OF APPLYING THE LIMITATION ON TAXATION SET FORTH IN SECTION 11, ARTICLE XI, OREGON CONSTITUTION.

WHEREAS, the City Council of the City of Milwaukie, Oregon, has determined that a new tax base should be established as authorized by subsection (2), Section 11, Article XI, Oregon Constitution, in order to permit the proper operation of the city affairs within the limitation contained in Section 11, Article XI, Oregon Constitution, and

WHEREAS, it is necessary to submit the question of establishing a new tax base to the legal voters of the City of Milwaukie, Oregon, in accordance with said Constitutional provisions and the provisions of ORS 310.410,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MILWAUKIE, OREGON, that the following proposition shall be submitted in the manner prescribed in this Resolution to the legal voters of the City of Milwaukie, Oregon, at a special city tax base election to be held on November 6, 1962:

"Shall the City of Milwaukie, Clackamas County, Oregon, increase its tax base from \$54,771.98 to \$275,000.00?"

BE IT FURTHER RESOLVED that this special city tax base election be and the same hereby is called to be held concurrently with and as a part of the statewide regular election being held in the State of Oregon and in the City of Milwaukie, Oregon, on November 6, 1962.

BE IT FURTHER RESOLVED that the regular polling places designated by the County Court of Clackamas County, Oregon, in the voting precincts in the City of Milwaukie hereby are designated as the polling places for the city tax base election; the poll books adopted by the County Court of Clackamas County, Oregon, as the poll books for the statewide regular election for the voting precincts in the City of Milwaukie hereby are adopted as the poll books for the city tax election; and the judges and clerks of election appointed by the County Court of Clackamas County, Oregon, to serve at the statewide regular election hereby are designated as the judges and clerks of and for the city tax base election.

BE IT FURTHER RESOLVED that the judges and clerks shall hold their respective offices as designated for the statewide regular election.

BE IT FURTHER RESOLVED that the polls for the city tax base election shall be opened in each of the voting precincts at the same hour, and shall be kept open until the same hour, as the polls are opened and closed for the statewide regular election that will be held on the same day.

BE IT FURTHER RESOLVED that the polls for the city tax base election shall be opened in each of the voting precincts at the same hour, and shall be kept open until the same hour, as the polls are opened and closed for the statewide regular election that will be held on the same day.

BE IT FURTHER RESOLVED that notice of the city tax base election shall be given by posting notices thereof in three public places in each voting precinct within the City of Milwaukie, Oregon, at least ten days prior to the date of election, and by publishing notice thereof once in the Milwaukie Review, the official city paper at least ten days prior to the said election.

BE IT FURTHER RESOLVED that the notice published in the said newspaper and the notices to be posted in three public places in each voting precinct shall be in substantially the following form:

On November 6, 1962, in the City of Milwaukie, Clackamas County, from 8:00 A.M. till 8:00 P.M. Pacific Standard Time, a special city election will be held at which the following proposition will be submitted to the legal voters of the City of Milwaukie for their approval or rejection:



This proposition, if adopted, will establish a new tax base for the City of Milwaukie, Oregon, for the purpose of applying the limitation on taxation set forth in Section 11, Article XI, Oregon Constitution. The present tax base is \$ 54,771.98, the new tax base if adopted will be \$ 275,000.00, and the new tax base if adopted shall first apply to the levy for the fiscal year next following this election.

The city and county precincts within the City of Milwaukie will have uniform boundaries and the same election boards. The polling places in the City for the special city tax base election will be at the same places as provided by Clackamas County for the state-wide regular election to be held on the same day, November 6, 1962, and to such places as the election boards may legally adjourn.

The City Council by resolution has appointed the identical officers appointed by the County Court of Clackamas County, Oregon, for the state-wide regular election, as the judges and clerks of the special city tax base election to serve in each of the polling places in the respective precincts to which they are appointed by the County Court of Clackamas County, Oregon.

BE IT FURTHER RESOLVED that the Recorder of the City of Milwaukie, Oregon, is hereby empowered and directed to cause to be posted and published the Notice of Special Election as herein set forth, and to make all further arrangements and to secure the necessary supplies for said election.

Motion carried and so ordered.

The Mayor opened the hearing on the matter of withdrawal of recently annexed area by Ordinance Number 929 and by election on August 22, 1962, from the Milwaukie Rural Fire Protection District and called for any objection to the same. There was no citizen present who made objection and no written objection had been received. The Mayor declared the hearing closed.

Ordinance Number 940 was taken up and read for its first reading. It was moved by Sedgwick and seconded by Baer that Ordinance Number 940 be passed to its second reading, Motion carried and so ordered.

A letter from the Milwaukie Planning Commission, regarding a zone change for the Kronberg Property at the southwest end of Kellogg Lake, was read as follows:





WHEREAS, by virtue of Ordinance Number 530 of the City of Milwaukie, Oregon, the City Council is authorized to make changes in parking regulations by resolution to become effective when proper markers and signs have been installed; and

BE IT FURTHER RESOLVED that all vehicles proceeding in a southerly direction on 42nd Street be and they are hereby required to come to a complete stop before entering the intersection of 42nd Street with Washington Street in the City of Milwaukie, Oregon, and that a proper stop sign be posted at an appropriate place to indicate the required stop; and

BE IT FURTHER RESOLVED that all vehicles proceeding in a northerly direction along 46th Street be and they are hereby required to come to a complete stop before entering the intersection of 46th Street with Monroe Street in the City of Milwaukie, Oregon, and that a proper stop sign be posted at an appropriate place to indicate the required stop; and






BE IT FURTHER RESOLVED that the provisions of this Resolution shall be and become effective from and after the erection and posting of said signs as hereinabove required.
