

TOWN HALL, MILWAUKIE, OREGON, OCT. 9TH. 1923.

The two hundred fifty-ninth regular meeting of the Council of the Town of Milwaukie was held on the 9th. day of October, 1923. Meeting called to order by Mayor Cowell. Present; Mayor Cowell, Councilmen Kerr, Miller, McIntyre and Kleeb, Recorder Mathews and Marshal Keck. The minutes of the two hundred fifty-eight regular meeting of the Council held on the 11th day of September, 1923, and the minutes of the adjourned meeting of the two hundred fifty-eighth regular meeting held on the 20th. day of September, 1923, and the minutes of the special meeting of the Council held on the 24th day of September, 1923, were read and approved as read. Upon motion duly made and carried, M. S. Schrock was appointed one of the Viewers to assess benefits and damages on the proposed extension of 27th. Street. The Recorder was instructed to notify Mr. Carver to appear at the next Council meeting and show cause why the franchise of the Portland Southern R. R. Co. should not be revoked for its failure to place plank between its tracks on 29th Street, as ordered by the Council. Upon motion duly made and carried, Mr. Porter was instructed to prepare a map of numbering the houses in Milwaukie and to give a number to each house in said Town. Upon motion duly made and carried, Mr. Riley was instructed to take care of the garbage dump instead of Mr. Keck, and that all former actions of the Council conflicting with this order be rescinded.

TOWN HALL, MILWAUKIE, OREGON, OCTOBER 13TH. 1923.

A special meeting of the Council of the Town of Milwaukie was held on the 13th day of October, 1923. Meeting called to order by Mayor Cowell. Present; Mayor Cowell, Councilmen, Kerr, Miller, McIntyre and Kleeb, Recorder Mathews and Marshal Keck. The Mayor stated that the meeting was called for the purpose of appointing a viewer to assess benefits and damages on the proposed extension of 27th. Street, to act instead of M. S. Schrock, as Mr. Schrock is not qualified to act.

Upon motion duly made and carried, the action of the Council in appointing M. S. Schrock as a viewer to assess benefits and damages on the proposed extension of 27th. Street was rescinded. Upon motion duly made and carried, F. D. Farrington was appointed a viewer to assess benefits and damages on the proposed extension of 27th. Street.

Upon motion duly made and carried, Monday the 29th. day of October, 1923, at the hour of 8:30 A. M. of said day was the time and the City Hall in Milwaukie, Oregon was the place fixed for the meeting of the Viewers appointed to assess benefits and damages on the proposed extension of 27th. Street. Upon motion duly made and carried, the time of the meeting of Council was changed from 8:00 o'clock P. M. to 7:00 o'clock P. M. from November the 1st to April the 1st. of each year. Upon motion duly made and carried, the Council adjourned.
