

Town Hall, Milwaukie, Oregon, Oct. 18th. 1927.

A special meeting of the Council of Milwaukie was held on the 18th. day of October, 1927. Meeting called to order by Mayor Miller. Present, Mayor Miller, Councilmen Shindler, Sanders, Shrock and Dell, Recorder Mathews and Marshal Keck. Mayor Miller stated that the meeting was called for the purpose of considering the proposition of Mr. Hager in regard to installing a drain on 30th. Street from Washington Street in order that the water may drain into his mill pond to take the place of the water diverted from the mill pond by reason of the construction of the Milwaukie Sanitary Sewer.

Mayor Miller stated that Mr. Hager had agreed to pay \$300.00 toward the construction of the drain if the city would pay the balance of the cost. Upon motion duly made and carried, it was ordered that two test holes be dug and if sufficient water was found to accept Mr. Hager's proposition and install the drain.

Upon motion duly made and carried, Mr. Roetter was given ten days further time within which to complete the improvement of 30th Street. Upon motion duly made and carried, Mr. Roetter was given the price of 20 cents per square foot for putting in the concrete corner on 30th. Street.

Upon motion duly made and carried, the Council adjourned.

TOWN HALL, MILWAUKIE, OREGON, NOV. 8TH. 1927.

The three hundred eighth regular meeting of the Council of the Town of Milwaukie was held on the 8th. day of November, 1927, Meeting called to order by Mayor Miller. Present, Mayor Miller, Councilmen Shindler, Sanders, Dell, Shrock and Earl, Recorder Mathews, and Marshal Keck. The minutes of the three hundred seventh regular meeting of the Council held on the 11th. day of October, 1927, and the minutes of the special meeting of the Council held on the 18th. day of October, 1927, were read and approved as read. Upon motion duly made and carried, the Mayor and Recorder were instructed to settle with Keating & Bade as soon as they complete the Hager drain, and draw warrants in payment of the same. A communication from the City Engineer in regard to the sewer assessments against the property of Judd Seaman and R. M. Peterson was read and ordered placed on file. A petition of property owners along Washington Street requesting the Council to improve said Street from Railroad Avenue easterly to the City limits was read and referred to the Street Committee for consideration. The Report of the Treasurer was read and ordered placed on file. The City Engineer having prepared and filed with the Recorder proposed assessment rolls for the 31st. Street Sewer, the Oak Street Sewer and for the improvement of 30th. Street, upon motion duly made and carried, the Council set the 29th. day of November, 1927, at the hour of 8:00 o'clock P. M. of said day, for hearing and considering objections, if any, to said proposed assessments. The report of the Water Supt. was read and ordered placed on file. The following bills were read and allowed by the Finance Committee, and upon motion duly made and carried, the Recorder was instructed to draw warrants in payment of the same:
