

Council Chamber, Milwaukie, Oregon, Nov. 14th. 1932.

The three hundred sixty-eight regular meeting of the Council of Milwaukie was held on the 14th. day of November, 1932. Meeting called to order by Mayor Miller. Present, Mayor Miller, Councilmen Shindler, Dean, Dell and Sanders, Recorder Mathews and Marshal Keck. The minutes of the three hundred sixty-seventh regular meeting of the Council held on the 10th. day of October, 1932, were read and approved as read. Upon motion duly made and unanimously carried, the following resolution was adopted:

BE IT RESOLVED BY THE COUNCIL that a special tax of \$10,485.00 be and hereby is levied against the taxable property within Milwaukie, Oregon, for city purposes for the year 1933, and that said special tax be apportioned among the several city funds as setforth and specified in the estimated budget for Milwaukie for the year 1933 prepared by the Budget Committee, which estimated budget is hereby referred to and made a part of this resolution.

Upon motion duly made and carried, Ordinance No. 319 entitled, "An Ordinance authorizing the issuance of an improvement bond of the Town of Milwaukie in the amount of \$298.60 and declaring an emergency," was taken up for the first reading. The Ordinance being read the roll call showed the following result: Ayes, Councilmen Shindler, Sanders, Dean and Dell. Noes, none. Ordinance No. 319 passed the first reading.

Upon motion duly made and carried, the rules were suspended and Ordinance No. 319 was taken up for the second reading and read by title only. The roll call showed the following result: Ayes, Councilmen, Sanders, Dean, Shindler and Dell. Noes, none. Ordinance No. 319 passed the second reading. Upon motion duly made and carried, the rules were suspended and Ordinance No. 319 was taken up for the third and final reading and read by title only. The roll call showed the following result: Ayes, Councilmen Shindler, Sanders, Dean and Dell. Noes, none. Ordinance No. 319 passed the third and final reading.

Upon motion duly made and carried, it was ordered that the registration books be closed at midnight Nov. 21st. 1932. The following were appointed Judges and Clerks of the city election to be held on the 5th. day of December, 1932: Ward 1, Judges, A. J. Walker, Ida Jameson and G. A. Taylor; Clerks, Ida Meaney and Florence Salters. Ward No. 2: Judges W. H. Grasle, Henry Davis and E. Kuppenbender. Clerks, Olive Shaw and Minerva Jones.

J. Miller, Mayor; William Adams, Recorder; Henry W. Wiseman, Treasurer; J. A. Keck, Marshal; Michael Walsh, Councilman at Large; Chas. F. Dean, and M. S. Shrock, Councilmen for Ward 1, and Will Sanders, Councilman for Ward 2. The City Recorder having requested that his books be audited before turning them over to his successor, upon motion duly made and carried, Mr. L. S. Phillips was employed to audit the City Recorder's books. Upon motion duly made and carried, it was declared that there was a majority of 178 votes cast against the proposed Ordinance No. 314.

Upon motion duly made and carried, it was ordered that the registration cards and files be turned over to the City Treasurer. Upon motion duly made and carried, M. S. Shrock was appointed Councilman for Ward No. 1, to fill the unexpired term of Leo R. Shindler, deceased. No further business coming before the meeting, upon motion duly made and carried, the meeting adjourned.
