

TOWN HALL, MILWAUKIE, OREGON, NOVEMBER 30th. 1926.

An adjourned meeting of the two hundred ninety-sixth regular meeting of the Council was held on the 30th. day of November, 1926.

Meeting called to order by Mayor Cowell. Present, Mayor Cowell, Councilmen Kerr, Grasley, Frey and Hazen, Recorder Mathews and Marshal Keck. Upon motion duly made and carried, R. S. Ramsey was appointed councilman of Ward No. 1, to serve until the 31st day of December, 1926. R. S. Ramsey was duly sworn in as Councilman. Upon motion made and carried, the Mayor was instructed to appoint a committee to investigate the condition of the sewer on Washington and Elmer Streets, the Committee to report to the Council at the next regular meeting.

Mayor Cowell appointed the entire Council as such Committee, the Committee to meet at 1:30 P. M. Saturday the 4th. day of December, 1926.

The Recorder was instructed to notify Frederick Hager, J. C. Hungerford, B. M. Fisch, J. P. Miller, A. H. Zanders, Philip Streib and Herman Ledding to meet with the Committee. Mr. H. A. Hagle was present and made application to have the city furnish him with water.

The matter was taken under advisement. Mr. Riley stated that numerous complaints had been made to him about the hoboes camped in the old powder house stealing small articles. Mr. Riley and Mr. Frey were appointed as a committee to see Mr. Harvey and found out what could be done in regard to keeping the hoboes out of the old powder house, and to report at the next regular meeting. Councilman Frey stated that there was some doubt about there being enough property owners signing the petition for the construction of a sewer on East Harrison Street to give the Council jurisdiction to proceed with the construction of the sewer, and that he would recommend that all prior proceedings in the matter be rescinded. Upon motion duly made and carried, all previous proceedings in the construction of the proposed sewer on East Harrison Street were rescinded. The following bills were read and allowed by the Finance Committee and upon motion duly made and carried, the Recorder was instructed to draw warrants on the several funds in payment of the same:
