TOWN HALL MILWAUKIE, OREGON, DECEMBER 11TH. 1916.

An adjourned meeting of the one hundred seventy-seventh regular meeting of the Town Council was held on the above named date. Meeting called to order by Mayor Pelton. Present, Mayor Pelton, Councilmen, Gracie, Snyder, Miller, Shindler and Counsell, and Recorder Mathews. Upon motion duly made and carried, Mayor Pelton, Councilman Gracie and Recorder Mathews were appointed as a Committee to interview Mr. Montague and explain just what amendments were desired to the City Charter.

Upon motion duly made and carried, the Chairman of the Street Committee was instructed to see that the Streets are properly repaired.

Upon motion of councilman Counsell seconded by councilman Gracie and carried, the Mayor and Recorder were instructed to execute a deed on behalf of the Town of Milwaukie conveying to N. H. Toates a triangular tract of land adjoining his property on Shindler Street, upon receiving from Mr. Toates a deed conveying to Milwaukie a tract of land on Shindler Street. Upon motion duly made and carried, the Recorder was instructed to notify the P. R. L. & P. Co. to move the Arc light at 24th and Harrison Streets to the first pole east of the Reaverton and Willsburg Railroad Company's track on Harrison Street. Upon motion duly made and carried, the Recorder was instructed to draw a warrant in favor of the Neptune Meter Company for \$63.00 in payment for meter.

The following bills were read and allowed by the Finance Committee and upon motion duly made and carried, the Recorder was instructed to draw warrants in payment of the same:

A special meeting of the Council was held on the above named date. Meeting called to order by Mayor Pelton. Present, Mayor Pelton, Councilmen, Gracie, Snyder, Miller, Shindler and Counsell, and Recorder Mathews. Upon motion duly made and carried, the recorder was instructed to prepare an ordinance regulating the sale and discharge of firecrackers within the Town of Milwaukie. Mr. Esterly, attorney for Montague-O'Reilly Co. was present and requested the Council to pay the Company for putting in the bridge on Front Street. Upon motion duly made and carried, Mayor Pelton and councilman Snyder were instructed to obtain from Mr. Montague a written opinion as to whether or not the Town of Milwaukie would waive any of its rights in regard to the Front Street improvement by paying Montague-O'Reilly Company for putting in the bridge on said Street.

The matter of changing the light in the front part of the City Hall was left with the Light Committee. Upon motion duly made and carried, the Council adjourned.
