

TOWN HALL, MILWAUKIE, OREGON, DECEMBER 9TH. 1929.

The three hundred thirty-third regular meeting of the Council of Milwaukie was held on the 9th. day of December, 1929. Meeting called to order by Mayor Miller. Present, Mayor Miller, Councilmen, Shindler, Sanders, Dean and Dell, Recorder Mathews and Marshal Keck. The minutes of the three hundred thirty second regular meeting of the Council held on the 12th. day of November, 1929, and the minutes of the special meeting of the Council held on the 3rd. day of December, 1929, were read and approved as read. Upon motion duly made and carried, the recommendation of the City Engineer that the Contractor be allowed an additional \$33.60 for the construction of the Myrtle Street sewer on the account of encountering cement gravel in the excavation, was adopted. Upon motion duly made and carried, the City Engineer was instructed to apportion the cost of the Myrtle Street sewer on the same basis as the 31st. Street sewer. Upon motion duly made and carried, the 23rd. day of December, 1929, at the hour of 8:00 o'clock P. M. was fixed as the time and the Council Chamber of the City Hall as the place for hearing objections to the acceptance of the completion of the Myrtle Street Sewer.

Upon motion duly made and carried, the bill of R. S. Milln for \$50.00 for preliminary survey of East Jefferson and Willard Streets was allowed and ordered paid out of the Street Fund. The following bills were read and allowed by the Finance Committee and upon motion duly made and carried, the Recorder was instructed to draw warrants on the several funds in payment of the same:

An adjourned meeting of the three hundred thirty third regular meeting of the Council of Milwaukie was held on the 23rd day of December, 1929. Meeting called to order by Mayor Miller. Present, Mayor Miller, Councilmen Shindler, Sanders and Dell, and recorder Mathews. There being no objections made to the acceptance of the Myrtle Street sewer, upon motion duly made and carried, the construction of the Myrtle Street Sewer was accepted. The City Engineer having prepared and filed with the Recorder the proposed assessment to pay the cost of the construction of the Myrtle Street Sewer, upon motion duly made and carried, the 13th day of January, 1930, at the hour of 8:00 o'clock P. M. of said day was the time fixed as the time and the City Hall as the place for hearing and considering objections, if any, to said proposed assessment. The proposed contract between the City of Portland and the City of Milwaukie for furnishing Milwaukie with Bull Run Water was read, and upon motion duly made and carried, the Mayor and Recorder were instructed and directed to execute the proposed contract on behalf of the City of Milwaukie with the City of Portland in quadruplicate and return the same to the City of Portland for its execution of the same. Upon motion duly made and carried, the Council adjourned.
