Meeting having been called to order by Mayor Streib, attention was called to Ordinance No. 66 which has been posted the required length of time and was subject to the disposal of the Council. Title of Ordinance No. 66 being "An Ordinance providing for the improvement of Monroe St. from the east curb line of Front Street to the west side line of Main Street."

Moved by Councilman Lehman seconded by Councilmen Kelso that the Ordinance be taken up for final passage. Carried. Upon roll call the vote resulted as follows:- Ayes, Councilmen Kelso, Lehman and Knight; Nays, none; so the ordinance passed.

Moved that the Recorder be instructed to advertise for bids for the improvement of Monroe Street, bids to be opened at the Regular meeting January 9th, 1912. Carried.

Councilman Kelso sought information in reference to Block 39 for the improvement of Main Street. It was thought best to consult the City Attorney.

Engineer Campbell reported on the work on Washington Street as follows:- With the Street Committee he had gone over said street and found it completed with the exception of a few places where it was low and that the ravine in front of Fisher's place was not properly banked on the sides so as to prevent it from washing down. At the same time the work on Fourth and Oak Streets were inspected. Attention was called to a stretch of 8 feet of walk on Oak Street which would need a little attention.

Moved, seconded and duly carried that the Engineer issue a certificate of acceptance for Washington, Fourth and Oak Streets, and that that the recorder be instructed to post notices of acceptance for the respective streets, provided the contractors fill the streets to bring

it to the proper grade where it was low and bank the sides of the grade over the ravine so as to protect it from washing away, <sup>the</sup> the side walk on Oak Street be put in shape and that the work in general be put as required by the plans and specifications in the contract.
